

Cameron-Liebler sets of generators in finite classical polar spaces

Abstract

Cameron-Liebler sets were originally defined as collections of lines (“line classes”) in $\text{PG}(3, q)$ sharing certain properties with line classes of symmetric tactical decompositions. While there are many equivalent characterisations, these objects are defined as sets of lines whose characteristic vector lies in the image of the transpose of the point-line incidence matrix of $\text{PG}(3, q)$, and so combinatorially they behave like a disjoint union of point-pencils. Recently, the concept of a Cameron-Liebler set has been generalized to several other settings. In this article we introduce Cameron-Liebler sets of generators in finite classical polar spaces. For each of the polar spaces except $\mathcal{W}(2n + 1, q)$, $n \geq 3$ and q odd, we give a list of characterisations that mirrors those for Cameron-Liebler line sets, and also prove some classification results.

1 Introduction

In [7], Cameron and Liebler investigated collineation groups of $\text{PG}(n, q)$ having the same number of orbits on points and lines. A line orbit of such a group possesses special properties, leading to the notion of what are now called Cameron-Liebler line classes in $\text{PG}(n, q)$. These line sets have mostly been studied in $\text{PG}(3, q)$ where many equivalent characterisations, both algebraic and combinatorial, are known; we refer to [33] for an overview.

In recent years the concept of Cameron-Liebler classes has been generalised to many other contexts, for example Cameron-Liebler k -classes in $\text{PG}(2k + 1, q)$ were introduced in [36], and Cameron-Liebler classes in finite sets were described in [14]. The central problem for Cameron-Liebler classes, regardless of the context, is to determine for which parameters x a Cameron-Liebler class exists, and to classify the examples admitting a given parameter x . Constructions of Cameron-Liebler line classes in $\text{PG}(3, q)$ and classification results were obtained in [6, 7, 10, 21, 22, 23, 20, 26, 27, 35]. For Cameron-Liebler classes in finite sets a complete classification has been described in [14]. Classification results for Cameron-Liebler k -classes in $\text{PG}(2k + 1, q)$ were found in [28, 36].

In this article we will introduce Cameron-Liebler sets of generators in polar spaces (we do not call them classes to avoid confusion with the classes of generators on a hyperbolic quadric). Our generalization will be motivated by the following purely combinatorial definition for Cameron-Liebler line classes of $\text{PG}(3, q)$.

Definition 1.1. A set of lines \mathcal{L} in $\text{PG}(3, q)$ is a Cameron-Liebler line class with parameter x if any line $\ell \in \mathcal{L}$ is disjoint to $(x-1)q^2$ lines of \mathcal{L} , and any line $\ell \notin \mathcal{L}$ is disjoint to xq^2 lines of \mathcal{L} .

The collection of lines through a fixed point (a *point-pencil*) contains $q^2 + q + 1$ lines, and is a Cameron-Liebler line class in $\text{PG}(3, q)$ with parameter 1. If we were able to take \mathcal{L} a disjoint union of x point-pencils, a line $\ell \in \mathcal{L}$ would be disjoint to $(x-1)q^2$ lines of \mathcal{L} , and a line $\ell \notin \mathcal{L}$ would be disjoint to xq^2 lines of \mathcal{L} , hence \mathcal{L} would be a Cameron-Liebler line class with parameter x . While it is impossible to have two disjoint point-pencils in $\text{PG}(3, q)$, a Cameron-Liebler line class in $\text{PG}(3, q)$ with parameter x can be thought of as a set of lines that combinatorially (with respect to disjointness) behaves like a union of x disjoint point-pencils.

Section 2 will introduce the necessary background while Section 3 is devoted to proving the characterisation results, which will differ among the polar spaces. In Section 4 we will present some examples of Cameron-Liebler sets of generators on polar spaces and in Section 6 we will present some classification results. Section 5 is devoted to the rank 2 case, the generators (lines) of generalised quadrangles.

2 Preliminaries

Distance-regular graphs and association schemes

Our work will rely on many tools from the theory of association schemes, which were introduced in [4]. We also refer to [5, Chapter 2] and [15] as important texts on this topic. While we will follow the approach given in [41], we will primarily focus on how these concepts apply to the specialized case of distance-regular graphs. More information on this important class of association schemes can be found in [5].

Throughout this paper, we will denote the matrix of all ones by J . The all-one vector of length m will be denoted by \mathbf{j}_m ; we denote it by \mathbf{j} if its length is clear from the context.

Definition 2.1. A d -class association scheme \mathcal{R} on a finite non-empty set Ω is a set $\{R_0, \dots, R_d\}$ of $d+1$ symmetric relations on Ω such that the following properties hold.

1. R_0 is the identity relation.
2. \mathcal{R} is a partition of Ω^2 .
3. For $x, z \in \Omega$ with $(x, z) \in R_k$, the number of $y \in \Omega$ such that $(x, y) \in R_i$ and $(y, z) \in R_j$, equals a constant p_{ij}^k (and is thus independent of x and z).

Let Γ be a graph with diameter d , and let $\delta(u, v)$ denote the distance between vertices u and v of Γ . The i th-neighborhood of a vertex v is the set $\Gamma_i(v) = \{w : d(v, w) = i\}$; we similarly define Γ_i to be the i th distance graph of Γ , that is, the vertex set of Γ_i is the same as for Γ , with adjacency in Γ_i defined by the i th distance relation in Γ . We say that Γ is *distance-regular* if the distance relations of Γ give the relations of a d -class association scheme, that is, for every choice of $0 \leq i, j, k \leq d$, all vertices v and w with $\delta(v, w) = k$ satisfy $|\Gamma_i(v) \cap \Gamma_j(w)| = p_{ij}^k$ for some constant p_{ij}^k .

In a distance-regular graph, we have that $p_{ij}^k = 0$ whenever $i+j < k$ or $k < |i-j|$. A distance-regular graph Γ is necessarily regular with degree p_{11}^0 ; more generally, each distance graph Γ_i is regular with degree $k_i = p_{i1}^0$. An equivalent definition of distance-regular graphs is the existence of the constants $b_i = p_{i+1,1}^i$ and $c_i = p_{i-1,1}^i$ for $0 \leq i \leq d$ (notice that $b_d = c_0 = 0$). This collection of values $\{b_0, \dots, b_{d-1}; c_1, \dots, c_d\}$ is called the *parameter set* of the distance-regular graph, and all of the remaining p_{ij}^k are determined by these values.

For the remainder of this section, Γ will be a distance-regular graph with diameter d and vertex set $\Omega = \{x_1, \dots, x_n\}$. Let A_k be the adjacency matrix of Γ_k for $0 \leq k \leq d$, that is, A_k will have a 1 in the (i, j) position if $\delta(x_i, x_j) = k$ and 0 otherwise. This gives a set of $d+1$ symmetric matrices

A_0, \dots, A_d with $A_0 = I$, $\sum_{i=0}^d A_i = J$, and $A_i A_j = \sum_{k=0}^d p_{ij}^k A_k$. The ordering on Ω used to form the matrices A_i will be considered to be fixed, giving us an ordered basis for the vector space \mathbb{R}^Ω .

The \mathbb{R} -vector space generated by the matrices A_0, \dots, A_d is closed under matrix multiplication and so it is a $(d+1)$ -dimensional commutative \mathbb{R} -algebra \mathcal{A} , which is known as the *Bose-Mesner algebra* of the association scheme. We can also obtain a second important basis for the Bose-Mesner algebra. A matrix E is *idempotent* if $E^2 = E$, and an idempotent matrix is called *minimal* if it cannot be written as the sum of two nonzero idempotent matrices.

Theorem 2.2. The Bose-Mesner algebra of a d -class association scheme on Ω has a unique basis $\{E_0, \dots, E_d\}$ of minimal idempotents. Moreover, $E_i E_j = \delta_{ij} E_i$. The subspaces V_0, \dots, V_d , with $V_i = \text{im}(E_i)$, form an orthogonal decomposition of \mathbb{R}^Ω .

Since $|\Omega| = n$, we always consider $E_0 = \frac{1}{n} J$. Since $\{A_i\}$ and $\{E_i\}$ are both bases for \mathcal{A} , there are values $P_{j,i}$ such that $A_i = \sum_{j=0}^d P_{j,i} E_j$. From this it is clear that $A_i E_j = P_{j,i} E_j$, therefore $V_j = \text{im}(E_j)$ is a subspace of eigenvectors for the matrix A_i with corresponding eigenvalue $P_{j,i}$ (the $P_{j,i}$ are thus called the *eigenvalues* of the association scheme).

Note that V_j is not necessarily an eigenspace for all incidence matrices as it could happen that for a particular matrix A_i , two eigenvalues coincide. E.g., for the matrix A_0 there is only one eigenvalue and hence \mathbb{R}^Ω is the only eigenspace. However since it is true that each eigenspace is an orthogonal sum of the V_j , and Γ (with adjacency matrix A_1) has exactly $d+1$ distinct eigenvalues, we refer to the V_j as the *eigenspaces* of the underlying association scheme.

The eigenspaces of an association scheme give us a powerful tool for working with the Bose-Mesner algebra, as is shown by the following result which holds for any association scheme.

Lemma 2.3. Let \mathcal{R} be a d -class association scheme on the set Ω and let \mathcal{A} be the corresponding Bose-Mesner algebra. If $A \in \mathcal{A}$, then $\text{im}(A) = \text{im}(A^t)$ is a direct sum of eigenspaces of the association scheme.

Proof. All matrices in \mathcal{A} are symmetric, so $\text{im}(A) = \text{im}(A^t)$. Let E_0, \dots, E_d be the minimal idempotents of \mathcal{A} , giving a corresponding orthogonal decomposition $\mathbb{R}^\Omega = V_0 \perp \dots \perp V_d$. Since $A \in \mathcal{A}$, we can write $A = \sum_{i=0}^d c_i E_i$. We put \mathcal{I} to be the collection of indices for which $c_i \neq 0$. We will now show that $\text{im}(A) = (\perp_{i \in \mathcal{I}} V_i)$. If $\mathbf{v} \in \text{im}(A)$ there is a vector \mathbf{w} such that $\mathbf{v} = A\mathbf{w}$, and thus

$$\mathbf{v} = A\mathbf{w} = \left(\sum_{i=0}^d c_i E_i \right) \mathbf{w} = \sum_{i=0}^d c_i (E_i \mathbf{w}) \in (\perp_{i \in \mathcal{I}} V_i) ,$$

since $V_i = \text{im}(E_i)$. On the other hand, for any $\mathbf{v} \in (\perp_{i \in \mathcal{I}} V_i)$ we have $\mathbf{v} = \sum_{i \in \mathcal{I}} \mathbf{v}_i$ with each $\mathbf{v}_i \in V_i$, and thus $\mathbf{v} = \sum_{i \in \mathcal{I}} E_i \mathbf{w}_i$ for some collection of vectors $\mathbf{w}_i \in \mathbb{R}^\Omega$. Thus we have that

$$A \left(\sum_{i \in \mathcal{I}} \frac{1}{c_i} E_i \mathbf{w}_i \right) = \left(\sum_{j=0}^d c_j E_j \right) \left(\sum_{i \in \mathcal{I}} \frac{1}{c_i} E_i \mathbf{w}_i \right) = \sum_{i \in \mathcal{I}} \sum_{j=0}^d \frac{c_j}{c_i} \delta_{ij} E_i \mathbf{w}_i = \sum_{i \in \mathcal{I}} E_i \mathbf{w}_i = \mathbf{v} ,$$

and so $\mathbf{v} \in \text{im}(A)$. □

Polar spaces

Polar spaces of rank $d \geq 2$ are a kind of incidence geometries having subspaces of dimension $0, \dots, d-1$. In this article we will only discuss finite polar spaces (polar spaces having a finite number of subspaces). The axiomatic introduction of polar spaces is due to Veldkamp ([43, 44]) and Tits ([40]). Polar spaces of rank 2 are called generalised quadrangles. We define them separately.

Definition 2.4. A *generalised quadrangle of order (s, t)* , with $s, t \geq 1$, is a point-line geometry satisfying the following axioms.

- Two distinct points are incident with at most one line.

- Any line is incident with $s + 1$ points and any point is incident with $t + 1$ lines.
- For any point P and line ℓ , with P not incident with ℓ , there is a unique tuple (P', ℓ') such that P is incident with ℓ' , P' is incident with ℓ and P' is incident with ℓ' .

For any generalised quadrangle \mathcal{Q} of order (s, t) we can define the *dual generalised quadrangle* \mathcal{Q}^D by interchanging the roles of points and lines in \mathcal{Q} . The generalised quadrangle \mathcal{Q}^D has order (t, s) .

The reason for introducing the polar spaces of rank 2 separately is the famous result by Tits ([40]) which states that all finite polar spaces of rank at least 3 are *classical polar spaces*. Therefore we immediately introduce finite classical polar spaces.

Definition 2.5. A *finite classical polar space* is an incidence geometry consisting of the totally isotropic subspaces of a non-degenerate quadratic or non-degenerate reflexive sesquilinear form on a vector space \mathbb{F}_q^{n+1} .

Throughout this article we will consider the finite classical polar spaces as substructures of $\text{PG}(n, q)$, and describe all dimensions as projective dimensions. The subspaces of dimension 0 (vector lines), 1 (vector planes) and 2 (vector solids) are called *points*, *lines* and *planes*, respectively.

A bilinear form for which all vectors are isotropic is called *symplectic*. A sesquilinear form on V is called *Hermitian* if the corresponding field automorphism θ is an involution and $f(v, w) = f(w, v)^\theta$ for all $v, w \in V$. We now list the finite classical polar spaces of rank d .

- The hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ embedded in $\text{PG}(2d-1, q)$. It arises from a hyperbolic quadratic form on $V(2d, q)$. Its standard equation is $X_0X_1 + \cdots + X_{2d-2}X_{2d-1} = 0$.
- The parabolic quadric $\mathcal{Q}(2d, q)$ embedded in $\text{PG}(2d, q)$. It arises from a parabolic quadratic form on $V(2d+1, q)$. Its standard equation is $X_0^2 + X_1X_2 + \cdots + X_{2d-1}X_{2d} = 0$.
- The elliptic quadric $\mathcal{Q}^-(2d+1, q)$ embedded in $\text{PG}(2d+1, q)$. It arises from an elliptic quadratic form on $V(2d+2, q)$. Its standard equation is $X_0X_1 + \cdots + X_{2d-2}X_{2d-1} + g(X_{2d}, X_{2d+1}) = 0$ with g a homogeneous irreducible quadratic polynomial over \mathbb{F}_q .
- The Hermitian polar space $\mathcal{H}(2d-1, q^2)$ embedded in $\text{PG}(2d-1, q^2)$. It arises from a Hermitian form on $V(2d, q^2)$, constructed using the field automorphism $x \mapsto x^q$. Its standard equation is $X_0^{q+1} + X_1^{q+1} + \cdots + X_{2d-1}^{q+1} = 0$.
- The Hermitian polar space $\mathcal{H}(2d, q^2)$ embedded in $\text{PG}(2d, q^2)$. It arises from a Hermitian form on $V(2d+1, q^2)$, constructed using the field automorphism $x \mapsto x^q$. Its standard equation is $X_0^{q+1} + X_1^{q+1} + \cdots + X_{2d}^{q+1} = 0$.
- The symplectic polar space $\mathcal{W}(2d-1, q)$ embedded in $\text{PG}(2d-1, q)$. It arises from a symplectic form on $V(2d, q)$. For this symplectic form we can choose an appropriate basis $\{e_1, \dots, e_d, e'_1, \dots, e'_d\}$ of $V(2d, q)$ such that $f(e_i, e_j) = f(e'_i, e'_j) = 0$ and $f(e_i, e'_j) = \delta_{i,j}$, with $1 \leq i, j \leq d$.

Definition 2.6. The subspaces of maximal dimension (being $d-1$) of a polar space of rank d are called *generators*. We define the *parameter* e of a polar space \mathcal{P} over \mathbb{F}_q as $\log_q(x-1)$ with x the number of generators through a $(d-2)$ -space of \mathcal{P} .

The parameter of a polar space only depends on the type of the polar space and not on its rank. Table 1 gives an overview.

Now we discuss a remarkable property of the hyperbolic quadrics.

Remark 2.7. We define a relation \sim on the set Ω of generators of a hyperbolic quadric $\mathcal{Q}^+(2d+1, q)$ in the following way: $\pi \sim \pi' \Leftrightarrow \dim(\pi \cap \pi') \equiv d \pmod{2}$. This relation is an equivalence relation and it has two equivalence classes, which necessarily partition the set Ω . These equivalence classes are commonly called the *Greek* and *Latin* generators.

We note that if d is even, then two generators in the same class cannot be disjoint. If d is odd, then two generators from different classes cannot be disjoint.

Table 1: The parameter of the finite classical polar spaces.

We now introduce the *Gaussian binomial coefficient* $\begin{bmatrix} n \\ k \end{bmatrix}_q$ for positive integers n, k and prime power $q \geq 2$:

$$\begin{bmatrix} n \\ k \end{bmatrix}_q = \prod_{i=1}^k \frac{q^{n-k+i} - 1}{q^i - 1} = \frac{(q^n - 1) \cdots (q^{n-k+1} - 1)}{(q^k - 1) \cdots (q - 1)}.$$

The number $\begin{bmatrix} n \\ k \end{bmatrix}_q$ equals the number of k -dimensional subspaces of the vector space \mathbb{F}_q^n , equivalently the number of $(k-1)$ -spaces in $\text{PG}(n-1, q)$. The Gaussian binomial coefficients admit the following relation $\begin{bmatrix} n \\ k \end{bmatrix}_q = \begin{bmatrix} n \\ n-k \end{bmatrix}_q$, which follows immediately from duality. Another important result regarding Gaussian binomial coefficients is the following analogue of the binomial theorem.

Lemma 2.8. For integers $n, k \geq 0$ and prime power $q \geq 2$ we have

$$\sum_{k=0}^n \begin{bmatrix} n \\ k \end{bmatrix}_q q^{\binom{k}{2}} t^k = \prod_{k=0}^{n-1} (1 + q^k t).$$

We can express the number of subspaces of a polar space given its parameter and rank using Gaussian binomial coefficients.

Lemma 2.9 ([5, Lemma 9.4.1]). For a finite classical polar space \mathcal{P} of rank d with parameter e , embedded in a projective space over \mathbb{F}_q , the number of k -spaces of \mathcal{P} is given by

$$\begin{bmatrix} d \\ k+1 \end{bmatrix}_q \prod_{i=1}^{k+1} (q^{d+e-i} + 1).$$

In particular, the number of generators of a finite classical polar space of rank d with parameter e , embedded in a projective space over \mathbb{F}_q , equals $\prod_{i=0}^{d-1} (q^{e+i} + 1)$, and the number of points equals $\begin{bmatrix} d \\ 1 \end{bmatrix}_q (q^{d+e-1} + 1)$.

Corollary 2.10. For a finite classical polar space \mathcal{P} of rank d with parameter e , embedded in a projective space over \mathbb{F}_q , the number of k -spaces of \mathcal{P} through a fixed m -space is given by

$$\begin{bmatrix} d-m-1 \\ k-m \end{bmatrix}_q \prod_{i=1}^{k-m} (q^{d-m+e-i-1} + 1).$$

In particular, the number of generators through a fixed point of a finite classical polar space of rank d with parameter e , embedded in a projective space over \mathbb{F}_q , equals $\prod_{i=0}^{d-2} (q^{e+i} + 1)$.

Distance-regular graphs from generators of finite polar spaces

We can use the set of generators of a finite classical polar space to construct a distance-regular graph.

Definition 2.11. For a finite classical polar space \mathcal{P} of rank d we define the corresponding *dual polar graph* as follows: its vertices are the generators of \mathcal{P} and two vertices are adjacent if the corresponding generators meet in a $(d-2)$ -space.

Theorem 2.12. The dual polar graph of a finite classical polar space over \mathbb{F}_q of rank d and with parameter e is a distance-regular graph with diameter d and parameter set $\{b_0, \dots, b_{d-1}; c_1, \dots, c_d\}$ with

$$b_i = q^{i+e} \begin{bmatrix} d-i \\ 1 \end{bmatrix}_q, \quad 0 \leq i \leq d-1 \quad \text{and} \quad c_i = \begin{bmatrix} i \\ 1 \end{bmatrix}_q, \quad 1 \leq i \leq d.$$

Two vertices are at distance j if the corresponding generators meet in a $(d-j-1)$ -space.

Using the terminology of association schemes, we will take a finite classical polar space \mathcal{P} of rank d and parameter e and let Ω be its set of generators (with some fixed ordering). Note that, by Lemma 2.9, $|\Omega| = \prod_{i=0}^{d-1} (q^{e+i} + 1)$. We will consider Γ to be the dual polar graph of \mathcal{P} , giving $d+1$ distance graphs Γ_i with adjacency matrices A_i for $0 \leq i \leq d$. This gives an orthogonal decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp \dots \perp V_d$ of \mathbb{R}^Ω where the V_i are the eigenspaces of the association scheme defined by Γ . Recall that $V_0 = \langle \mathbf{j} \rangle$. The remaining eigenspaces V_1, \dots, V_d are ordered using the following result described in [42], originating in [16].

Theorem 2.13. Let \mathcal{P} be a finite classical polar space of rank d and, for $1 \leq t \leq d$, let C_k be the incidence matrix between the $(k-1)$ -spaces and the generators of \mathcal{P} . Then the eigenspaces V_1, \dots, V_d of the association scheme of the dual polar graph for \mathcal{P} can be ordered so that $\text{im}(C_k^t) = V_0 \perp \dots \perp V_k$. In particular, $V_k = \text{im}(C_k^t) \cap \ker(C_{k-1})$.

Then the eigenvalue of the i th distance graph Γ_i corresponding to the subspace V_j is given by

$$P_{j,i} = \sum_{u=\max(0,j-i)}^{\min(j,d-i)} (-1)^{j+u} \begin{bmatrix} d-j \\ d-i-u \end{bmatrix}_q \begin{bmatrix} j \\ u \end{bmatrix}_q q^{\binom{u+i-j}{2} + \binom{j-u}{2} + e(u+i-j)}.$$

The *disjointness graph* Γ_d will have special importance for our work, this is the graph for which two vertices are adjacent if and only if the corresponding generators of the polar space have empty intersection. The eigenvalues of Γ_d are given by

$$P_{j,d} = (-1)^j q^{\binom{d}{2} + (d-j)(e-j)}.$$

Lemma 2.14. Let \mathcal{P} be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e . The number of generators disjoint to a given generator equals $q^{\binom{d}{2} + de}$.

Proof. This number is given by the eigenvalue of the disjointness graph Γ_d on the eigenspace V_0 , so the result follows from the above formula for $P_{0,d}$. \square

We will frequently be interested in the eigenspace of the minimal eigenvalue of Γ_d . Most of the following details can be found in the proof of [34, Theorem 8] and in [41, Corollary 4.3.17].

Theorem 2.15. Let \mathcal{P} be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e . Let $V_0 \perp V_1 \perp \dots \perp V_d$ be the orthogonal decomposition in eigenspaces of \mathbb{R}^Ω with Ω the set of generators of \mathcal{P} , as above. The eigenvalue of the disjointness relation of the generators for the subspace V_1 is $m = -q^{\binom{d-1}{2} + e(d-1)}$.

- If $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, with d odd, then the minimal eigenvalue $-q^{\binom{d}{2}}$ appears only for V_d . The eigenvalue m only appears for V_1 .

- If $\mathcal{P} = \mathcal{H}(2d-1, q)$, with d odd, then the minimal eigenvalue $-q^{\binom{d}{2}}$ appears only for V_d , q a square. The eigenvalue m only appears for V_1 .

In all other cases m is the minimal eigenvalue. In three cases, there are two subspaces V_i for which it is an eigenvalue.

- If $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, with d even, then the minimal eigenvalue m appears for both V_1 and V_{d-1} .
- If $\mathcal{P} = \mathcal{Q}(2d, q)$, with d odd, or $\mathcal{P} = \mathcal{W}(2d-1, q)$, with d odd, then the minimal eigenvalue m appears for both V_1 and V_d .

In all remaining cases, namely $\mathcal{P} = \mathcal{Q}(2d, q)$, with d even, $\mathcal{P} = \mathcal{W}(2d-1, q)$, with d even, $\mathcal{P} = \mathcal{Q}^-(2d+1, q)$, $\mathcal{P} = \mathcal{H}(2d-1, q)$, with d even and q a square, and $\mathcal{P} = \mathcal{H}(2d, q)$, the minimal eigenvalue is m and it appears only for V_1 .

We will also need the following result on the automorphism group of a finite classical polar space and the automorphism group of its dual polar graph.

Theorem 2.16 ([5, Theorem 9.4.3 and Chapter 10, pp. 334–336]). The automorphism group of a finite classical polar space acts transitively on pairs of disjoint generators. The automorphism group of a dual polar graph is distance-transitive (acts transitively on the set of pairs of vertices at the same distance).

These two groups coincide for all finite classical polar spaces except for the polar spaces $\mathcal{Q}^+(3, q)$.

For more information on dual polar graphs we refer to [5, Section 9.4]. The association schemes for k -dimensional subspaces of finite classical polar spaces were studied in [18, 38, 41] for arbitrary $k \leq d-1$.

Remark 2.17. For the polar space $\mathcal{Q}^+(2d-1, q)$ the generators are naturally partitioned into two sets Ω_1 and Ω_2 (the Latin and Greek generators, see Remark 2.7). For generators $\pi \in \Omega_j$ and $\pi' \in \Omega_{j'}$ with $(\pi, \pi') \in R_i$, $j, j' \in \{1, 2\}$ and $i \in \{0, \dots, d\}$, we know that $j = j'$ if i is even and that $j \neq j'$ if i is odd. So, we can define a $\lfloor \frac{d}{2} \rfloor$ -class association scheme for one class of generators Ω_j of $\mathcal{Q}^+(2d-1, q)$, namely $\mathcal{R}' = \{R'_0, R'_1, \dots, R'_{\lfloor \frac{d}{2} \rfloor}\}$ with $R'_i = R_{2i}$. The corresponding incidence matrices are $A'_0 = A_0, A'_1 = A_2, \dots$. Note that the eigenvalues $P_{j,i}$ and $P_{d-j,i}$ of the association scheme of $\mathcal{Q}^+(2d-1, q)$ are equal if i is even, so the eigenspaces of \mathcal{R}' are given by $V'_j \cap \mathbb{R}^{\Omega_j}$ with $V'_j = V_j \perp V_{d-j}$, $j = 0, \dots, \lfloor \frac{d}{2} \rfloor$. Here \mathbb{R}^{Ω_j} is seen as the subspace of \mathbb{R}^Ω of all vectors which have non-zero entries only on the positions corresponding to the generators of Ω_j .

Spreads and m -regular systems of polar spaces

We end this section by defining some substructures of polar spaces (including generalised quadrangles).

An m -regular system of a polar space \mathcal{P} is a set \mathcal{S} of generators such that any point of \mathcal{P} is contained in precisely m elements of \mathcal{S} . A 1-regular system is called a *spread*. Spreads of polar spaces have been studied intensively in the past decades, but the existence problem has not yet been solved for all polar spaces. An overview can be found in Table 2. It includes the classical generalised quadrangles (generalised quadrangles that are polar spaces of rank 2). For those generalised quadrangles spreads are sets of lines.

The number of generators in an m -regular system of a finite classical polar space over \mathbb{F}_q of rank d with parameter e equals $m(q^{d+e-1} + 1)$; this follows from basic counting. In particular, a spread is a set of $q^{d+e-1} + 1$ pairwise disjoint generators.

3 The characterisation theorems

As previously mentioned, the concept of a Cameron-Liebler set has been defined for finite sets and for finite projective geometries. We will analogously introduce Cameron-Liebler sets for finite classical polar spaces, and provide characterisations of these objects. These characterisations however will vary depending on the particular polar space.

We will discuss vectors and matrices in this section and the following ones. Vectors will always be column vectors. For sake of clarity we will denote vectors in boldface. For two vectors \mathbf{v}, \mathbf{w} , the inner product $\langle \mathbf{v}, \mathbf{w} \rangle$ is the standard dot product $\mathbf{v}^t \mathbf{w}$. The characteristic vector of a subset $S' \subseteq S$ is a vector whose positions are indexed by the elements of S and whose entries equal 1 if the element corresponding to the position of the entry is in S' , and 0 otherwise. Throughout the introduction to this section, \mathcal{P} will be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e . Continuing with the notation used for the association scheme of the dual polar graph, we will use Ω to denote the set of generators of \mathcal{P} , and V_0, V_1, \dots, V_d to denote the eigenspaces as defined in Lemma 2.13.

Our main goal is to generalize Definition 1.1 to sets of generators of \mathcal{P} . The idea is, if \mathcal{L} is a collection of generators of \mathcal{P} , then we will call \mathcal{L} a *Cameron-Liebler set with parameter x* if any generator $\pi \in \mathcal{L}$ is disjoint to $(x - 1)q^{\binom{d-1}{2} + e(d-1)}$ generators of \mathcal{L} , and any generator $\pi \notin \mathcal{L}$ is disjoint to $xq^{\binom{d-1}{2} + e(d-1)}$ generators of \mathcal{L} , i.e. taking χ to be the characteristic vector of \mathcal{L} , for any generator π of \mathcal{P} we have π disjoint from $(x - (\chi)_\pi)q^{\binom{d-1}{2} + e(d-1)}$ elements of \mathcal{L} . This main property will lead to subtly different definitions in various polar spaces, but the following result will be an important tool in investigating these objects.

Theorem 3.1. Let \mathcal{P} be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e , and let K be the generator disjointness matrix of \mathcal{P} . Let \mathcal{L} be a set of generators of \mathcal{P} with characteristic vector χ . The number of generators of \mathcal{L} disjoint from each fixed generator π of \mathcal{P} equals $(x - (\chi)_\pi)q^{\binom{d-1}{2} + e(d-1)}$ if and only if $\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}$ is a vector in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2} + e(d-1)}$.

Proof. Notice that the generator-disjointness matrix of \mathcal{P} is the adjacency matrix A_d of the association scheme for the dual polar graph of \mathcal{P} , and that $-q^{\binom{d-1}{2} + e(d-1)} = P_{1,d}$, the eigenvalue of A_d corresponding to the eigenspace V_1 . Let V be the eigenspace of K associated with this eigenvalue (which contains but is not necessarily equal to V_1). The entry on the position corresponding to a given generator π of the vector $K\chi$ is the number of generators disjoint to π that are contained

in \mathcal{L} . Hence, this number is $(x - (\chi)_\pi)q^{\binom{d-1}{2}+e(d-1)}$ if and only if

$$K\chi = q^{\binom{d-1}{2}+e(d-1)}(x\mathbf{j} - \chi).$$

The number of ones in a row of K equals the number of generators disjoint to a given generator, so by Lemma 2.14 we know that

$$K\mathbf{j} = q^{\binom{d}{2}+de}\mathbf{j}.$$

Let V be the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}+e(d-1)}$. Now, the vector $\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}$ is contained in V if and only if

$$\begin{aligned} K\left(\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}\right) &= -q^{\binom{d-1}{2}+e(d-1)}\left(\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}\right) \\ &= -q^{\binom{d-1}{2}+e(d-1)}\left(\chi - x\mathbf{j} + \frac{xq^{d+e-1}}{q^{d+e-1}+1}\mathbf{j}\right) \\ &= q^{\binom{d-1}{2}+e(d-1)}(x\mathbf{j} - \chi) - \frac{x}{q^{d+e-1}+1}q^{\binom{d}{2}+de}\mathbf{j} \\ &= q^{\binom{d-1}{2}+e(d-1)}(x\mathbf{j} - \chi) - \frac{x}{q^{d+e-1}+1}K\mathbf{j}. \end{aligned}$$

So, the vector $\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}$ is contained in V if and only if

$$K\chi = q^{\binom{d-1}{2}+e(d-1)}(x\mathbf{j} - \chi),$$

which proves the result. \square

Definition 3.2. The set of all generators of a polar space through a fixed point is called a *point-pencil*.

From Corollary 2.10, the size of a point-pencil in \mathcal{P} is given by $\prod_{i=1}^{d-1}(q^{d+e-1}+1)$. If we let \mathcal{L} be a point-pencil, then the characteristic vector χ of \mathcal{L} is a column of A^t , where A is the point-generator adjacency matrix of \mathcal{P} .

Before presenting the results, we first discuss some lemmas that build up to the main characterisation theorems.

Lemma 3.3. Let \mathcal{P} be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e , that admits spreads, and let π be a generator of \mathcal{P} . Let G be an automorphism group of \mathcal{P} that acts transitively on the pairs of disjoint generators of \mathcal{P} and let \mathcal{C} be a set of generator spreads of \mathcal{P} which is a union of orbits of spreads under the action of G . Let \mathcal{L} be a set of generators of \mathcal{P} with characteristic vector χ . If the intersection number $|\mathcal{L} \cap \mathcal{S}|$ equals x for every spread $\mathcal{S} \in \mathcal{C}$, then

$$(i) \quad |\mathcal{L}| = x \prod_{i=0}^{d-2}(q^{e+i}+1);$$

$$(ii) \quad \text{the number of generators of } \mathcal{L} \text{ disjoint to } \pi \text{ equals } (x - (\chi)_\pi)q^{\binom{d-1}{2}+e(d-1)}.$$

Proof. Let n_i be the number of spreads in \mathcal{C} containing i given disjoint generators, $i = 1, 2$, and let n_0 be the total number of spreads in \mathcal{C} . Now G acts transitively on the pairs of disjoint generators. Consequently, the values n_i are independent of the chosen generators (and thus well defined) for $i = 0, 1, 2$, since \mathcal{C} is a union of spread orbits.

By counting the tuples (τ', S) , with $S \in \mathcal{C}$ and τ' an element (generator) of S , we find that

$$n_0(q^{e+d-1}+1) = n_1 \prod_{i=0}^{d-1}(q^{e+i}+1) \quad \Leftrightarrow \quad n_0 = n_1 \prod_{i=0}^{d-2}(q^{e+i}+1).$$

Now, let τ be a generator of \mathcal{P} . By counting the tuples (τ', S) , with $S \in \mathcal{C}$ containing τ , and τ' an element of S different (and thus necessarily disjoint) from τ , and using Lemma 2.14, we find that

$$n_1q^{e+d-1} = n_2q^{\binom{d}{2}+de} \quad \Leftrightarrow \quad n_1 = q^{\binom{d-1}{2}+e(d-1)}n_2.$$

In order to prove (i) we count the tuples (π', S) , with S a spread of \mathcal{P} in \mathcal{C} and π' a generator of $\mathcal{L} \cap S$. On the one hand, we find n_0 spreads in \mathcal{C} , each containing x generators that belong to \mathcal{L} . On the other hand, each generator of \mathcal{L} is contained in n_1 generators. Hence,

$$|\mathcal{L}| = x \frac{n_0}{n_1} = x \prod_{i=0}^{d-2} (q^{e+i} + 1).$$

Now we count the tuples (π', S) , with $S \in \mathcal{C}$ containing π , and π' a generator of $\mathcal{L} \cap S$ disjoint to π . On the one hand, there are n_1 spreads S in \mathcal{C} containing π and by the assumption $\mathcal{L} \cap S$ contains x generators, which are necessarily disjoint. So, there are $x - (\chi)_\pi$ possible choices for π' given S , namely $x - 1$ if $\pi \in \mathcal{L}$ and x if $\pi \notin \mathcal{L}$. On the other hand, for every generator π' we choose, there are n_2 spreads in \mathcal{C} containing π and π' . Consequently, the number of choices for π' equals

$$(x - (\chi)_\pi) \frac{n_1}{n_2} = (x - (\chi)_\pi) q^{\binom{d-1}{2} + e(d-1)}.$$

This concludes the proof of part (ii). \square

Remark 3.4. For any finite classical polar space its full automorphism group acts transitively on the pairs of disjoint generators by Theorem 2.16, so there are groups that fulfill the requirement for the group G in the above lemma.

The following results will be useful in the proofs of the characterisation theorems.

Lemma 3.5. Let \mathcal{P} be a finite classical polar space over \mathbb{F}_q of rank d and with parameter e , and let A be the point-generator incidence matrix of \mathcal{P} . Let \mathcal{S} be a set of generators of \mathcal{P} with characteristic vector χ .

- (i) For any $m \in \mathbb{N}$, the generator set \mathcal{S} is an m -regular system if and only if $\chi - \frac{m}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \mathbf{j} \in \ker(A)$.
- (ii) Let π be a fixed generator and let χ_π be the characteristic vector of the set $\{\pi\}$. If the generator set \mathcal{S} is the set of all generators disjoint to π , then

$$\chi - q^{\binom{d-1}{2} + e(d-1)} \left(\frac{1}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \mathbf{j} - \chi_\pi \right) \in \ker(A).$$

Proof. We denote the number of points of \mathcal{P} by n' and the number of generators of \mathcal{P} by n . It is immediate that $A\mathbf{j}_n = \left(\prod_{i=0}^{d-2} (q^{e+i} + 1) \right) \mathbf{j}_{n'}$ since every row in A contains $\prod_{i=0}^{d-2} (q^{e+i} + 1)$ ones as this is the number of generators through a point.

Now, the set \mathcal{S} is an m -regular system if and only if every point of \mathcal{P} is contained in precisely m generators of \mathcal{S} , hence if and only if $A\chi = m\mathbf{j}_{n'}$. The first statement now follows from

$$\chi - \frac{m}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \mathbf{j}_n \in \ker(A) \quad \Leftrightarrow \quad A\chi = \frac{m}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} A\mathbf{j}_n.$$

Let \mathbf{v}_π be the characteristic vector of π with the positions corresponding to the points of \mathcal{P} . Note that $A\chi_\pi = \mathbf{v}_\pi$. If the set \mathcal{S} is the set of all generators disjoint to π , then $A\chi = q^{\binom{d-1}{2} + e(d-1)} (\mathbf{j}_{n'} - \mathbf{v}_\pi)$ since every point not in π is contained in $q^{\binom{d-1}{2} + e(d-1)}$ generators skew to π by Lemma 2.14 (looking at the quotient geometry of the point). The second statement now follows from

$$\begin{aligned} & \chi - q^{\binom{d-1}{2} + e(d-1)} \left(\frac{1}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \mathbf{j}_n - \chi_\pi \right) \in \ker(A) \\ \Leftrightarrow & \quad A\chi = q^{\binom{d-1}{2} + e(d-1)} \left(\frac{1}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} A\mathbf{j}_n - A\chi_\pi \right). \end{aligned} \quad \square$$

The polar spaces $\mathcal{Q}^-(2d + 1, q)$, $\mathcal{Q}(4n, q)$, $\mathcal{Q}^+(4n + 1, q)$, $\mathcal{W}(4n - 1, q)$ and $\mathcal{H}(n, q^2)$

In this section we present the characterisation theorem for almost all classes of finite classical polar spaces, namely the elliptic quadrics, the parabolic quadrics of even rank, the hyperbolic quadrics of odd rank, the symplectic polar spaces of even rank and the Hermitian polar spaces. To simplify the statement of the theorem we will use the following notation.

Notation 3.6. The polar spaces $\mathcal{Q}^-(2d + 1, q)$, $\mathcal{Q}(2d, q)$ with d even, $\mathcal{Q}^+(2d - 1, q)$ with d odd, $\mathcal{W}(2d - 1, q)$ with d even, $\mathcal{H}(2d - 1, q)$ with q a square, and $\mathcal{H}(2d, q)$ with q a square, are called the polar spaces of *type I*.

Now we present the characterisation theorem.

Theorem 3.7. Let \mathcal{P} be a polar space of type I of rank d and with parameter e over \mathbb{F}_q . Let \mathcal{L} be a set of generators of \mathcal{P} with characteristic vector χ . Let A be the point-generator incidence matrix of \mathcal{P} , and let K be the generator disjointness matrix of \mathcal{P} . Denote $\frac{|\mathcal{L}|}{\prod_{i=0}^{d-2} (q^{e+i} + 1)}$ by x . The four following statements are equivalent.

- (i) $\chi \in \text{im}(A^t)$.
- (ii) $\chi \in (\ker(A))^\perp$.
- (iii) For each fixed generator π of \mathcal{P} , the number of elements of \mathcal{L} disjoint from π equals $(x - (\chi)_\pi)q^{\binom{d-1}{2} + e(d-1)}$.
- (iv) The vector $\chi - \frac{x}{q^{d+e-1}+1}\mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2} + e(d-1)}$.

If \mathcal{P} admits a spread, then also the next two statements are equivalent to the previous ones.

- (v) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread \mathcal{S} of \mathcal{P} .
- (vi) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{P} , with \mathcal{C} a class of spreads which is a union of orbits under the action of an automorphism group of \mathcal{P} that acts transitively on the pairs of disjoint generators of \mathcal{P} .

Proof. Statement (i) implies statement (ii) since $\text{im}(A^t) = (\ker(A))^\perp$. Now, we assume that (ii) is valid. Let π be a fixed generator and let χ_π be the characteristic vector of the set $\{\pi\}$. Let \mathcal{S}' be the set of all generators disjoint to π and denote its characteristic vector by $\chi_{\mathcal{S}'}$. By Lemma 3.5(ii) we can find a vector $\mathbf{v} \in \ker(A)$ such that

$$\chi_{\mathcal{S}'} = \mathbf{v} + q^{\binom{d-1}{2} + e(d-1)} \left(\frac{1}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \mathbf{j} - \chi_\pi \right).$$

The number of elements of \mathcal{L} disjoint from π equals $|\mathcal{S}' \cap \mathcal{L}|$. We find

$$\begin{aligned} |\mathcal{S}' \cap \mathcal{L}| &= \langle \chi_{\mathcal{S}'}, \chi \rangle = \langle \mathbf{v}, \chi \rangle + q^{\binom{d-1}{2} + e(d-1)} \left(\frac{1}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} \langle \mathbf{j}, \chi \rangle - \langle \chi_\pi, \chi \rangle \right) \\ &= q^{\binom{d-1}{2} + e(d-1)} \left(\frac{|\mathcal{L}|}{\prod_{i=0}^{d-2} (q^{e+i} + 1)} - (\chi)_\pi \right) = (x - (\chi)_\pi) q^{\binom{d-1}{2} + e(d-1)}, \end{aligned}$$

since $\langle \mathbf{v}, \chi \rangle = 0$ by the assumption. This proves (iii).

By Theorem 3.1 statements (iii) and (iv) are equivalent. Now, we assume that (iv) is valid. We consider the association scheme of the generators of \mathcal{P} , with matrices $I = A_0, A_1, \dots, A_d = K$ and corresponding decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp \dots \perp V_d$, with Ω the set of generators of \mathcal{P} , using the ordering as in Section 2. The eigenvalue of K corresponding to V_1 is $-q^{\binom{d-1}{2} + e(d-1)}$.

By Theorem 2.15 V_1 is the unique subspace in this decomposition admitting $-q^{\binom{d-1}{2}+e(d-1)}$ as eigenvalue since \mathcal{P} is of type I. It now follows from (iv) that $\boldsymbol{\chi} - \frac{x}{q^{d+e-1}+1}\boldsymbol{j} \in V_1$. Since $\boldsymbol{j} \in V_0$ we know that $\boldsymbol{\chi} \in V_0 \oplus V_1$, and by Lemma 2.13 $V_0 \oplus V_1 = \text{im}(A^t)$. So, statement (i) follows.

We have proved that the first four statements are equivalent. From now on we assume that \mathcal{P} admits a spread. We note that by Remark 3.4 the existence of a spread of \mathcal{P} implies the existence of a class \mathcal{C} as in statement (vi). This shows that statement (vi) is not an empty statement, which is important for the following argument. We show that (ii) implies (v) and that (vi) implies (iii). Since (v) clearly implies (vi), this shows that statements (v) and (vi) are both equivalent to the statements (i)-(iv).

We assume that (ii) is valid. Let \mathcal{S} be a spread of \mathcal{P} , with characteristic vector $\boldsymbol{\chi}_{\mathcal{S}}$. By Lemma 3.5(i) we can find a vector $\boldsymbol{w} \in \ker(A)$ such that $\boldsymbol{\chi}_{\mathcal{S}} = \boldsymbol{w} + \frac{1}{\prod_{i=0}^{d-2}(q^{e+i}+1)}\boldsymbol{j}$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \boldsymbol{\chi}, \boldsymbol{\chi}_{\mathcal{S}} \rangle = \langle \boldsymbol{\chi}, \boldsymbol{w} \rangle + \frac{1}{\prod_{i=0}^{d-2}(q^{e+i}+1)} \langle \boldsymbol{\chi}, \boldsymbol{j} \rangle = \frac{|\mathcal{L}|}{\prod_{i=0}^{d-2}(q^{e+i}+1)} = x,$$

since $\langle \boldsymbol{\chi}, \boldsymbol{w} \rangle = 0$ by the assumption. This proves (v).

By Lemma 3.3(ii) statement (vi) implies (iii). \square

Definition 3.8. Let \mathcal{P} be a finite classical polar space of type I. A generator set \mathcal{L} that fulfils one of the statements in Theorem 3.7 (and consequently all of them) is called a *Cameron-Liebler set with parameter* $x = \frac{|\mathcal{L}|}{\prod_{i=0}^{d-2}(q^{e+i}+1)}$.

It follows from the definition that there is a direct link between the parameter and the size of a Cameron-Liebler set. Rewritten, we get the following.

Corollary 3.9. Let \mathcal{P} be a finite classical polar space of type I over \mathbb{F}_q of rank d and with parameter e . If \mathcal{L} is a Cameron-Liebler set with parameter x , then $|\mathcal{L}| = x \prod_{i=0}^{d-2}(q^{e+i}+1)$.

We have proved that the size of the intersection of a Cameron-Liebler set and a spread only depends on the parameter of the Cameron-Liebler set. If a spread exists, this is a defining property. We show that for regular systems a similar property holds, however it is in general not defining.

Corollary 3.10. Let \mathcal{P} be a finite classical polar space of type I over \mathbb{F}_q of rank d and with parameter e , that admits an m -regular system \mathcal{S} . If \mathcal{L} is a Cameron-Liebler set with parameter x , then $|\mathcal{L} \cap \mathcal{S}| = mx$.

Proof. Denote the characteristic vectors of \mathcal{S} and \mathcal{L} by $\boldsymbol{\chi}_{\mathcal{S}}$ and $\boldsymbol{\chi}$, respectively. By Lemma 3.5(i) we can find a vector $\boldsymbol{w} \in \ker(A)$ such that $\boldsymbol{\chi}_{\mathcal{S}} = \boldsymbol{w} + \frac{m}{\prod_{i=0}^{d-2}(q^{e+i}+1)}\boldsymbol{j}$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \boldsymbol{\chi}, \boldsymbol{\chi}_{\mathcal{S}} \rangle = \langle \boldsymbol{\chi}, \boldsymbol{w} \rangle + \frac{m}{\prod_{i=0}^{d-2}(q^{e+i}+1)} \langle \boldsymbol{\chi}, \boldsymbol{j} \rangle = \frac{m|\mathcal{L}|}{\prod_{i=0}^{d-2}(q^{e+i}+1)} = mx,$$

since $\langle \boldsymbol{\chi}, \boldsymbol{w} \rangle = 0$ by Theorem 3.7(ii). \square

The polar spaces $\mathcal{Q}^+(4n-1, q)$

In this section we present the characterisation theorem for one class of polar spaces, namely the hyperbolic quadrics of even rank. The discussion of the Cameron-Liebler sets of generators in these polar spaces heavily relies on the fact that there are two classes of generators on a hyperbolic quadric. For the relation with spreads the following lemma is important.

Lemma 3.11. Let \mathcal{S} be a generator spread of $\mathcal{Q}^+(4n-1, q)$, and let Ω_1 and Ω_2 be the two classes of generators. Then either $\mathcal{S} \subseteq \Omega_1$ or $\mathcal{S} \subseteq \Omega_2$.

Proof. This is immediate, as two generators of a different class cannot have an empty intersection since the rank of $\mathcal{Q}^+(4n-1, q)$ is even. \square

Because of the previous lemma we present a characterisation theorem similar to Theorem 3.7 for one class of generators instead of the complete set of generators. Some lemmas that we have proved before have an analogue for this situation.

Lemma 3.12. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, and let A be the incidence matrix of points of $\mathcal{Q}^+(2d-1, q)$ and generators in \mathcal{G} . Let $\mathcal{S} \subseteq \mathcal{G}$ be a set of generators with characteristic vector χ .

- (i) The generator set \mathcal{S} is an m -regular system of $\mathcal{Q}^+(2d-1, q)$ if and only if $\chi - \frac{m}{\prod_{i=1}^{d-2} (q^i + 1)} \mathbf{j} \in \ker(A)$.
- (ii) Let π be a fixed generator in \mathcal{G} and let χ_π be the characteristic vector of the set $\{\pi\}$. If the generator set \mathcal{S} is the set of all generators disjoint to π , then

$$\chi - q^{\binom{d-1}{2}} \left(\frac{1}{\prod_{i=1}^{d-2} (q^i + 1)} \mathbf{j} - \chi_\pi \right) \in \ker(A).$$

Proof. Analogous to the proof of Lemma 3.5, for both (i) and (ii). \square

Lemma 3.13. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, and let K be the disjointness matrix of \mathcal{G} . Let $\mathcal{L} \subseteq \mathcal{G}$ be a set of generators of \mathcal{P} with characteristic vector χ . The number of generators of \mathcal{G} disjoint to a given generator π of \mathcal{G} equals $(x - (\chi)_\pi) q^{\binom{d-1}{2}}$ if and only if $\chi - \frac{x}{q^{d-1} + 1} \mathbf{j}$ is a vector in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}}$.

Proof. Analogous to the proof of Theorem 3.1. Note that all generators of $\mathcal{Q}^+(2d-1, q)$, d even, that are disjoint to a given generator $\pi \in \mathcal{G}$, belong to \mathcal{G} . \square

We also need a counterpart for Lemma 2.13.

Lemma 3.14. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, d even, and let $A_0, A_1, \dots, A_{\frac{d}{2}}$ be the incidence matrices of the corresponding association scheme. Consider the eigenspace decomposition $\mathbb{R}^{\mathcal{G}} = V'_0 \perp V'_1 \perp \dots \perp V'_{\frac{d}{2}}$ related to this association scheme introduced in Remark 2.17. Let A be the incidence matrix of points of \mathcal{P} and generators in \mathcal{G} . Then, $\text{im}(A^t) = V'_0 \perp V'_1$.

Proof. Let P be a point of \mathcal{P} and let \mathbf{v}^t be the corresponding row of A . The vector \mathbf{v} is the characteristic vector of the collection of generators of \mathcal{G} through P . So, the entry of $A_1 \mathbf{v}$ corresponding to the generator π gives the number of generators in \mathcal{G} through P which have a $(d-3)$ -space in common with π . If $P \in \pi$, then this entry $(A_1 \mathbf{v})_\pi$ equals $\begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q q$ since there are $\begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q$ different $(d-3)$ -spaces through P in π , each contained in $q+1$ different generators of \mathcal{G} , namely π and q generators that have precisely this $(d-3)$ -space in common with π . If $P \notin \pi$, then the entry $(A_1 \mathbf{v})_\pi$ equals $\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$ since there is a unique generator of \mathcal{G} through the $(d-2)$ -space generated by P and a random $(d-3)$ -space in the $(d-2)$ -space $\pi \cap P^\perp$, with P^\perp the set of all points of \mathcal{P} collinear with P . So,

$$A_1 \mathbf{v} = q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q \mathbf{v} + (\mathbf{j} - \mathbf{v}) \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q = \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{v} + \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \mathbf{j}.$$

Also,

$$A_1 \mathbf{j} = q \begin{bmatrix} d \\ 2 \end{bmatrix}_q \mathbf{j}.$$

This implies that

$$\begin{aligned}
A_1 \left(\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j} \right) &= \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{v} - \left(\frac{q}{q^{d-1}+1} \begin{bmatrix} d \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{j} \\
&= \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{v} \\
&\quad - \left(\frac{q}{q^{d-1}+1} \left(\begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q + q^{d-2} \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{j} \\
&= \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{v} - \frac{1}{q^{d-1}+1} \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \mathbf{j} \\
&= \left(q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \left(\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j} \right).
\end{aligned}$$

Hence, $\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j}$ is contained in the eigenspace of A_1 with eigenvalue $q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$.

The eigenvalues $P_{j,1}^{\mathcal{G}}$ of the incidence matrix A_1 for the eigenspaces V'_j (as in Remark 2.17) are the eigenvalues $P_{j,2} = P_{d-j,2}$ of the association scheme of the generators of \mathcal{P} . So $P_{j,1}^{\mathcal{G}}$ equals $q \left(\begin{bmatrix} d-j \\ 2 \end{bmatrix}_q + \begin{bmatrix} j \\ 2 \end{bmatrix}_q \right) - \begin{bmatrix} d-j \\ 1 \end{bmatrix}_q \begin{bmatrix} j \\ 1 \end{bmatrix}_q$ for $2 \leq j \leq \frac{d}{2}$, and further $P_{0,1}^{\mathcal{G}} = q \begin{bmatrix} d \\ 2 \end{bmatrix}_q$ and $P_{1,1}^{\mathcal{G}} = q \begin{bmatrix} d-1 \\ 2 \end{bmatrix}_q - \begin{bmatrix} d \\ 1 \end{bmatrix}_q$. It is important to notice that V'_1 is the only eigenspace with eigenvalue $P_{1,1}^{\mathcal{G}}$. Consequently, $\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j} \in V'_1$ and so, $\mathbf{v} \in V'_0 \perp V'_1$ since $\mathbf{j} \in V'_0$. This implies that $\text{im}(A^t) \subseteq V'_0 \perp V'_1$.

Now, consider the matrix $A^t A$. This matrix has the same image as A^t . Furthermore $A^t A$ lies in the Bose-Mesner algebra of the association scheme, since the entry $(A^t A)_{\pi, \pi'}$ is the number of common points of π and π' , and so

$$A^t A = \sum_{i=0}^{\frac{d}{2}-1} \begin{bmatrix} d-2i \\ 1 \end{bmatrix}_q A_i.$$

By Lemma 2.3, this implies that $\text{im}(A^t) = \text{im}(A^t A)$ is a sum of eigenspaces V'_i . The image of A^t equals thus V'_0 , V'_1 or $V'_0 \perp V'_1$ since $\text{im}(A^t) \subseteq V'_0 \perp V'_1$ and it is non-empty. On the one hand, it is clear that $\mathbf{j} \in \text{im}(A^t)$ because $A^t \mathbf{j} = \begin{bmatrix} d \\ 1 \end{bmatrix}_q \mathbf{j}$, hence $V'_0 \subseteq \text{im}(A^t)$. On the other hand, consider a column \mathbf{v} of A^t . Then $\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j}$ is a non-zero vector of V'_1 by the above and the observation that $\mathbf{v} \notin \langle \mathbf{j} \rangle$. Since both \mathbf{v} and \mathbf{j} are contained in $\text{im}(A^t)$, also $\mathbf{v} - \frac{1}{q^{d-1}+1} \mathbf{j}$ is contained in $\text{im}(A^t)$ and consequently $V'_1 \subseteq \text{im}(A^t)$. So we conclude that $\text{im}(A^t) = V'_0 \perp V'_1$. \square

Now we present the characterisation theorem.

Theorem 3.15. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, d even. Let $\mathcal{L} \subseteq \mathcal{G}$ be a set of generators of \mathcal{P} with characteristic vector χ . Let A be the incidence matrix of points of \mathcal{P} and generators in \mathcal{G} , and let K be the disjointness matrix of \mathcal{G} . Denote $\frac{|\mathcal{L}|}{\prod_{i=1}^{d-2} (q^i+1)}$ by x . The four following statements are equivalent.

- (i) $\chi \in \text{im}(A^t)$.
- (ii) $\chi \in (\ker(A))^{\perp}$.

(iii) For each fixed generator $\pi \in \mathcal{G}$ the number of elements of \mathcal{L} disjoint from π equals $(x - (\boldsymbol{\chi})_\pi)q^{\binom{d-1}{2}}$.

(iv) The vector $\boldsymbol{\chi} - \frac{x}{q^{d-1}+1}\mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}}$.

If \mathcal{P} admits a spread, then also the next two statements are equivalent to the previous ones.

(v) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread \mathcal{S} of \mathcal{P} whose elements are in \mathcal{G} .

(vi) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{P} whose elements are in \mathcal{G} , with \mathcal{C} a class of spreads which is a union of orbits under the action of an automorphism group that acts transitively on the pairs of disjoint generators of \mathcal{G} .

Proof. Statement (i) implies statement (ii) since $\text{im}(A^t) = (\ker(A))^\perp$. Now, we assume that (ii) is valid. Let $\pi \in \mathcal{G}$ be a fixed generator and let $\boldsymbol{\chi}_\pi$ be the characteristic vector of the set $\{\pi\}$. Let $\mathcal{S}' \subset \mathcal{G}$ be the set of all generators disjoint to π and denote its characteristic vector by $\boldsymbol{\chi}_{\mathcal{S}'}$. By Lemma 3.12(ii) we can find a vector $\mathbf{v} \in \ker(A)$ such that

$$\boldsymbol{\chi}_{\mathcal{S}'} = \mathbf{v} + q^{\binom{d-1}{2}} \left(\frac{1}{\prod_{i=1}^{d-2} (q^i + 1)} \mathbf{j} - \boldsymbol{\chi}_\pi \right).$$

The number of elements of \mathcal{L} disjoint from π equals $|\mathcal{S}' \cap \mathcal{L}|$. We find

$$\begin{aligned} |\mathcal{S}' \cap \mathcal{L}| &= \langle \boldsymbol{\chi}_{\mathcal{S}'}, \boldsymbol{\chi} \rangle = \langle \mathbf{v}, \boldsymbol{\chi} \rangle + q^{\binom{d-1}{2}} \left(\frac{1}{\prod_{i=1}^{d-2} (q^i + 1)} \langle \mathbf{j}, \boldsymbol{\chi} \rangle - \langle \boldsymbol{\chi}_\pi, \boldsymbol{\chi} \rangle \right) \\ &= q^{\binom{d-1}{2}} \left(\frac{|\mathcal{L}|}{\prod_{i=1}^{d-2} (q^i + 1)} - (\boldsymbol{\chi})_\pi \right) = (x - (\boldsymbol{\chi})_\pi)q^{\binom{d-1}{2}}, \end{aligned}$$

since $\langle \mathbf{v}, \boldsymbol{\chi} \rangle = 0$ by the assumption. This proves (iii).

By Theorem 3.13 statements (iii) and (iv) are equivalent. Now, we assume that (iv) is valid. We consider the association scheme of the generators in \mathcal{G} , introduced in Remark 2.17, with matrices $I = A_0, A_1, \dots, A_{\frac{d}{2}} = K$ and corresponding decomposition $\mathbb{R}^{\mathcal{G}} = V'_0 \perp V'_1 \perp \dots \perp V'_{\frac{d}{2}}$. The eigenvalue of K corresponding to V'_1 is $-q^{\binom{d-1}{2}}$. By Lemma 2.15 and Remark 2.17 V'_1 is the unique subspace in this decomposition admitting $-q^{\binom{d-1}{2}}$ as eigenvalue. It now follows from (iv) that $\boldsymbol{\chi} - \frac{x}{q^{d-1}+1}\mathbf{j} \in V'_1$. Since $\mathbf{j} \in V_0$ we know that $\boldsymbol{\chi} \in V'_0 \oplus V'_1$, and by Lemma 3.14 $V'_0 \oplus V'_1 = \text{im}(A^t)$. So, statement (i) follows.

We have proved that the first four statements are equivalent. From now on we assume that \mathcal{P} admits a spread. We note that by Remark 3.4 the existence of a spread of \mathcal{P} implies the existence of a class \mathcal{C} as in statement (vi). This shows that statement (vi) is not an empty statement, which is important for the following argument. We show that (ii) implies (v) and that (vi) implies (iii). Since (v) clearly implies (vi), this shows that statements (v) and (vi) are both equivalent to the statements (i)-(iv).

We assume that (ii) is valid. Let $\mathcal{S} \subseteq \mathcal{G}$ be a spread of \mathcal{P} , with characteristic vector $\boldsymbol{\chi}_{\mathcal{S}}$. By Lemma 3.12(i) we can find a vector $\mathbf{w} \in \ker(A)$ such that $\boldsymbol{\chi}_{\mathcal{S}} = \mathbf{w} + \frac{1}{\prod_{i=1}^{d-2} (q^i + 1)} \mathbf{j}$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \boldsymbol{\chi}, \boldsymbol{\chi}_{\mathcal{S}} \rangle = \langle \boldsymbol{\chi}, \mathbf{w} \rangle + \frac{1}{\prod_{i=1}^{d-2} (q^i + 1)} \langle \boldsymbol{\chi}, \mathbf{j} \rangle = \frac{|\mathcal{L}|}{\prod_{i=1}^{d-2} (q^i + 1)} = x,$$

since $\langle \boldsymbol{\chi}, \mathbf{w} \rangle = 0$ by the assumption. This proves (v).

Finally we assume that (vi) is valid. We denote the class of generators different from \mathcal{G} by \mathcal{G}' . Any automorphism of \mathcal{P} either fixes both \mathcal{G} and \mathcal{G}' , or else switches the sets \mathcal{G} and \mathcal{G}' . Let H be the subgroup of G (necessarily of index 2) that fixes both \mathcal{G} and \mathcal{G}' setwise. The subgroup H acts transitively on the pairs of disjoint generators in \mathcal{G} , since G acts transitively on the pairs of disjoint generators of \mathcal{P} . By Lemma 3.3(ii) statement (vi) implies (iii) since the set of all spreads in \mathcal{C} whose elements are contained in \mathcal{G} is a union of orbits under the action of H . \square

As for the polar spaces of type I, we use this theorem to define Cameron-Liebler sets. Two corollaries of this theorem, similar to Corollaries 3.9 and 3.10 follow.

Definition 3.16. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even. A generator set $\mathcal{L} \subseteq \mathcal{G}$ that fulfills one of the statements in Theorem 3.7 (and consequently all of them) is called a *Cameron-Liebler set with parameter* $x = \frac{|\mathcal{L}|}{\prod_{i=1}^{d-2} (q^i + 1)}$.

Corollary 3.17. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even. If \mathcal{L} is a Cameron-Liebler set of \mathcal{G} with parameter x , then $|\mathcal{L}| = x \prod_{i=1}^{d-2} (q^i + 1)$.

Corollary 3.18. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, that admits an m -regular system \mathcal{S} . If \mathcal{L} is a Cameron-Liebler set with parameter x , then $|\mathcal{L} \cap \mathcal{S}| = mx$.

Proof. Analogous to the proof of Corollary 3.10, now using Lemma 3.12. \square

Using the definition of Cameron-Liebler sets for a class of generators, we can define Cameron-Liebler sets for the hyperbolic quadrics of even rank themselves. First we prove a characterisation theorem.

Theorem 3.19. Let \mathcal{L} be a set of generators of $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, d even, with characteristic vector χ . Let Ω_1 and Ω_2 be the two classes of generators of \mathcal{P} and let K be the disjointness matrix of the generators of \mathcal{P} . For any x the three following statements are equivalent.

- (i) $\mathcal{L} \cap \Omega_1$ and $\mathcal{L} \cap \Omega_2$ are Cameron-Liebler sets with parameter x of Ω_1 and Ω_2 , respectively.
- (ii) For each fixed generator π the number of elements of \mathcal{L} disjoint from π equals $(x - (\chi)_\pi) q^{\binom{d-1}{2}}$.
- (iii) The vector $\chi - \frac{x}{q^{d-1}+1} \mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}}$.

If \mathcal{P} admits a spread, then also the next two statements are equivalent to the previous ones.

- (iv) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread \mathcal{S} of \mathcal{P} .
- (v) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{P} , with \mathcal{C} a class of spreads which is a union of orbits under the action of an automorphism group that acts transitively on the pairs of disjoint generators of \mathcal{G} .

Proof. We define $\mathcal{L}_i = \mathcal{L} \cap \Omega_i$, $i = 1, 2$. We know $\mathcal{L} = \mathcal{L}_1 \cup \mathcal{L}_2$.

Since d is even, two disjoint generators necessarily belong to the same generator class, see Remark 2.7. Hence, statements (i) and (ii) are equivalent by Theorem 3.15 and Definition 3.16. By Theorem 3.1 we know that statements (ii) and (iii) are equivalent.

From now on we assume that \mathcal{P} admits a spread. Recall from Lemma 3.11 that each spread of \mathcal{P} is a subset of either Ω_1 or Ω_2 . Then it follows immediately from Theorem 3.15 that (i) is equivalent with both statement (iv) and statement (v). \square

Definition 3.20. A generator set \mathcal{L} of $\mathcal{Q}^+(2d-1, q)$, d even, that fulfills one of the statements in Theorem 3.19 (and consequently all of them) is called a *Cameron-Liebler set with parameter* x .

Corollary 3.21. Let \mathcal{L} be a Cameron-Liebler set of $\mathcal{Q}^+(2d-1, q)$, d even, with parameter x . Then $|\mathcal{L}| = x \prod_{i=0}^{d-2} (q^i + 1)$.

Remark 3.22. The characterisation of the Cameron-Liebler sets of the hyperbolic quadric $\mathcal{P} = \mathcal{Q}^+(2d-1, q)$, d even, is very similar to the characterisation of the polar spaces of type I. There is however no characterisation based on the image or kernel of a matrix. One can easily check that all generator sets whose incidence vector is contained in the image of the transposed incidence matrix of points and generators of \mathcal{P} are indeed Cameron-Liebler sets of \mathcal{P} , but the converse is not true: the image of the incidence matrix of points and generators of \mathcal{P} does not contain the incidence vectors of all Cameron-Liebler sets of \mathcal{P} .

For the Cameron-Liebler sets of the classes of \mathcal{P} we find a characterisation similar to the ones for polar spaces of type I including a characterisation using the image of a matrix. For this reason we focus here and in the final section of this paper on the Cameron-Liebler sets of a class of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, rather than on the Cameron-Liebler sets of the hyperbolic quadric itself.

The polar spaces $\mathcal{Q}(4n+2, q)$, all q , and $\mathcal{W}(4n+1, q)$, q even

In this section we present the characterisation theorem for two classes of polar spaces, namely the parabolic quadrics of odd rank and the symplectic polar spaces of odd rank over a field with even characteristic. To simplify the statements of the theorem we will use the following notation.

Notation 3.23. The polar spaces $\mathcal{Q}(2d, q)$, with d odd, and $\mathcal{W}(2d-1, q)$, with d odd and q even, are called the polar spaces of *type III*.

Note that all polar spaces of type III have parameter $e = 1$.

Remark 3.24. There is a strong connection between the two classes of polar spaces of type III if q is even. Consider the parabolic quadric $\mathcal{Q}(2d, q)$, q even, and let N be its nucleus. This is the unique point such that any line through N is a tangent line to $\mathcal{Q}(2d, q)$. Projecting $\mathcal{Q}(2d, q)$ from N onto a hyperplane α disjoint to N yields the symplectic polar space $\mathcal{W}(2d-1, q)$, q even. For more information about this link between $\mathcal{W}(2d-1, q)$, q even, and $\mathcal{Q}(2d, q)$, q even, we refer to [24, Chapter 22] and [39, Chapter 11].

Remark 3.25. Consider the parabolic quadric $\mathcal{P} = \mathcal{Q}(2d, q)$ with d odd. Any non-tangent hyperplane meets \mathcal{P} in either a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ or in an elliptic quadric $\mathcal{Q}^-(2d-1, q)$. Let \mathcal{S} be an m -regular system of \mathcal{P} and let α be a hyperplane meeting $\mathcal{Q}(2d, q)$ in a hyperbolic quadric Q , necessarily also of rank d . We know that $|\mathcal{S}| = m(q^d + 1)$, and then by counting the points of Q , we find that precisely $2m$ of the generators in \mathcal{S} are contained in Q . We know that the generators of Q can be divided in two classes and since d is odd, any two disjoint generators must belong to different classes. Hence, if \mathcal{S} is a spread ($m = 1$), the two generators of \mathcal{S} that are contained in Q necessarily belong to different classes.

From the previous observation it follows that the set of all generators of one class of a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ embedded in $\mathcal{Q}(2d, q)$, d odd, has precisely one generator in common with every spread. This generator set is called a *hyperbolic class*. Note that \mathcal{P} does not necessarily contain a spread.

By Remark 3.24 we know the connection between the polar spaces $\mathcal{Q}(2d, q)$, q even, and $\mathcal{W}(2d-1, q)$, q even. Consequently, there are also hyperbolic quadrics of rank d embedded in $\mathcal{W}(2d-1, q)$, q even, and the hyperbolic classes can be defined in the same way. In particular there is a 1-1-correspondence between the spreads of $\mathcal{Q}(2d, q)$, q even, and $\mathcal{W}(2d-1, q)$, q even, through the projection from the nucleus N of $\mathcal{Q}(2d, q)$. So the hyperbolic classes of $\mathcal{W}(2d-1, q)$, q even, also have precisely one generator in common with every spread.

Some lemmas using point-pencils that we have proved before have an analogue for hyperbolic classes.

Lemma 3.26. Let \mathcal{P} be a polar space of type III over \mathbb{F}_q of rank d , and let B be the incidence matrix of hyperbolic classes and generators of \mathcal{P} . Let \mathcal{S} be a set of generators of \mathcal{P} with characteristic vector χ .

- (i) If the generator set \mathcal{S} is a spread, then $\chi - \frac{1}{\prod_{i=1}^{d-1}(q^i+1)}\mathbf{j} \in \ker(B)$.
- (ii) Let π be a fixed generator and let χ_π be the characteristic vector of the set $\{\pi\}$. If the generator set \mathcal{S} is the set of all generators disjoint to π , then

$$\chi - q^{\binom{d}{2}} \left(\frac{1}{\prod_{i=1}^{d-1}(q^i+1)} \mathbf{j} - \chi_\pi \right) \in \ker(B).$$

Proof. We denote the number of hyperbolic classes of \mathcal{P} by m and the number of generators of \mathcal{P} by n . It is immediate that $B\mathbf{j}_n = \left(\prod_{i=1}^{d-1}(q^i + 1)\right)\mathbf{j}_m$ since every row in B contains $\prod_{i=1}^{d-1}(q^i + 1)$ ones as this is the number of generators in one class of a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$.

Firstly, we assume that \mathcal{S} is a spread. By Remark 3.25 the spread \mathcal{S} has precisely one generator in common with every hyperbolic class of \mathcal{P} and hence $B\boldsymbol{\chi} = \mathbf{j}_m$. The statement now follows from

$$\boldsymbol{\chi} - \frac{1}{\prod_{i=1}^{d-1}(q^i + 1)}\mathbf{j}_n \in \ker(B) \quad \Leftrightarrow \quad B\boldsymbol{\chi} = \frac{1}{\prod_{i=1}^{d-1}(q^i + 1)}B\mathbf{j}_n \quad \Leftrightarrow \quad B\boldsymbol{\chi} = \mathbf{j}_m .$$

Secondly, we assume that \mathcal{S} is the set of all generators disjoint to π . Let \mathbf{v}_π be the characteristic vector of π with the positions corresponding to the hyperbolic classes of \mathcal{P} , i.e. on the position corresponding to the hyperbolic class C there is a one if $\pi \in C$ and a zero otherwise. Note that $B\boldsymbol{\chi}_\pi = \mathbf{v}_\pi$. A hyperbolic class C has no generators in common with \mathcal{S} if $\pi \in C$ and has $q^{\binom{d}{2}}$ generators in common with \mathcal{S} if $\pi \notin C$. Hence, $B\boldsymbol{\chi} = q^{\binom{d}{2}}(\mathbf{j}_m - \mathbf{v}_\pi)$. The second statement now follows from

$$\begin{aligned} \boldsymbol{\chi} - q^{\binom{d}{2}} \left(\frac{1}{\prod_{i=1}^{d-1}(q^i + 1)}\mathbf{j}_n - \boldsymbol{\chi}_\pi \right) &\in \ker(B) \\ \Leftrightarrow B\boldsymbol{\chi} &= q^{\binom{d}{2}} \left(\frac{1}{\prod_{i=1}^{d-1}(q^i + 1)}B\mathbf{j}_n - B\boldsymbol{\chi}_\pi \right) . \end{aligned} \quad \square$$

Now we present a lemma regarding the image of the matrix B^t that we introduced in the previous lemma. This is an analogue of Lemmas 2.13 and 3.14.

Lemma 3.27. Let \mathcal{P} be a polar space of type III of rank d over \mathbb{F}_q , and let A_0, A_1, \dots, A_d be the incidence matrices of the corresponding association scheme. Consider the eigenspace decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp \dots \perp V_d$ related to this association scheme using the classical order, with Ω the set of all generators of \mathcal{P} . Let B be the incidence matrix of hyperbolic classes and generators of \mathcal{P} . Then, $\text{im}(B^t) = V_0 \perp V_1 \perp V_d$.

Proof. Let Q be a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ embedded in \mathcal{P} , and let \mathcal{G} and \mathcal{L} be the two classes of generators of Q . Note that $\mathcal{G}, \mathcal{L} \subset \Omega$. Let $\mathbf{v}_\mathcal{G}$ and $\mathbf{v}_\mathcal{L}$ be the characteristic vectors of \mathcal{G} and \mathcal{L} respectively. Then both $\mathbf{v}_\mathcal{G}^t$ and $\mathbf{v}_\mathcal{L}^t$ are rows of B .

We now look at the vector $A_1\mathbf{v}_\mathcal{G}$. The entry of $A_1\mathbf{v}_\mathcal{G}$ corresponding to the generator π gives the number of generators in \mathcal{G} which have a $(d-2)$ -space in common with π . If $\pi \in \mathcal{G}$, then $(A_1\mathbf{v}_\mathcal{G})_\pi$ equals 0 since two generators of the same class cannot have a $(d-2)$ -space in common. If $\pi \in \mathcal{L}$, then $(A_1\mathbf{v}_\mathcal{G})_\pi$ equals $\begin{bmatrix} d \\ 1 \end{bmatrix}_q$ since there are $\begin{bmatrix} d \\ 1 \end{bmatrix}_q$ different $(d-2)$ -spaces in π , each contained in a unique generator of \mathcal{G} . If $\pi \notin \mathcal{G} \cup \mathcal{L}$, so π is not contained in Q , then the entry $(A_1\mathbf{v}_\mathcal{G})_\pi$ equals 1 since the $(d-2)$ -space $\pi \cap Q$ is contained in a unique generator belonging to \mathcal{G} . So,

$$A_1\mathbf{v}_\mathcal{G} = \begin{bmatrix} d \\ 1 \end{bmatrix}_q \mathbf{v}_\mathcal{L} + (\mathbf{j} - \mathbf{v}_\mathcal{G} - \mathbf{v}_\mathcal{L}) .$$

Analogously,

$$A_1\mathbf{v}_\mathcal{L} = \begin{bmatrix} d \\ 1 \end{bmatrix}_q \mathbf{v}_\mathcal{G} + (\mathbf{j} - \mathbf{v}_\mathcal{G} - \mathbf{v}_\mathcal{L}) .$$

This implies that

$$A_1(\mathbf{v}_\mathcal{G} - \mathbf{v}_\mathcal{L}) = - \begin{bmatrix} d \\ 1 \end{bmatrix}_q (\mathbf{v}_\mathcal{G} - \mathbf{v}_\mathcal{L}) ,$$

and hence that $\mathbf{v}_\mathcal{G} - \mathbf{v}_\mathcal{L}$ is an eigenvector of A_1 with eigenvalue $-\begin{bmatrix} d \\ 1 \end{bmatrix}_q$.

We have noted before, in the proof of Lemma 2.13, that the eigenvalues $P_{j,1}$ of the association scheme of a polar space are pairwise different. Hence, it follows that $\mathbf{v}_G - \mathbf{v}_L \in V_d$ since $P_{d,1} = -\begin{bmatrix} d \\ 1 \end{bmatrix}_q$.

Let A be the point-generator incidence matrix of \mathcal{P} and let \mathbf{v}_P^t be the row of A corresponding to P , so \mathbf{v}_P is the characteristic vector of the point-pencil through P . Let \mathcal{H} be the set of points in Q and let \mathcal{H}' be the set of points of \mathcal{P} not contained in Q . Then,

$$\mathbf{v}_G + \mathbf{v}_L = \frac{1}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q} \sum_{P \in \mathcal{H}} \mathbf{v}_P - \frac{\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q q^{d-1}} \sum_{P \in \mathcal{H}'} \mathbf{v}_P,$$

since each generator in $\mathcal{G} \cup \mathcal{L}$ contains $\begin{bmatrix} d \\ 1 \end{bmatrix}_q$ points of \mathcal{H} and no points of \mathcal{H}' , while every generator in $\Omega \setminus (\mathcal{G} \cup \mathcal{L})$ contains $\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$ points of \mathcal{H} and q^{d-1} points of \mathcal{H}' . Consequently, $\mathbf{v}_G + \mathbf{v}_L \in \text{im}(A^t)$.

By Lemma 2.13 we know that $\text{im}(A^t) = V_0 \perp V_1$.

Since $\mathbf{v}_G - \mathbf{v}_L \in V_d$ and $\mathbf{v}_G + \mathbf{v}_L \in \text{im}(A^t)$, we know that $\mathbf{v}_G, \mathbf{v}_L \in \text{im}(A^t) \oplus V_d$. The vectors \mathbf{v}_G^t and \mathbf{v}_L^t are arbitrary rows of B since Q can be chosen arbitrarily. It follows that $\text{im}(B^t) \subseteq \text{im}(A^t) \perp V_d = V_0 \perp V_1 \perp V_d$.

Now, consider the matrix $B^t B$. This matrix has the same image as B^t . Furthermore,

$$B^t B = \sum_{i=0}^d q^{d-i} A_i$$

since the entry $(B^t B)_{\pi, \pi'}$ is the number of hyperbolic classes containing both generators π and π' , which equals q^{k+1} if $\dim(\pi \cap \pi') = k$. So, $B^t B$ lies in the Bose-Mesner algebra of the association scheme of \mathcal{P} . By Lemma 2.3, this implies that $\text{im}(B^t) = \text{im}(B^t B)$ is a sum of eigenspaces V_i . Since $\text{im}^t(B) \subseteq V_0 \perp V_1 \perp V_d$, the space $\text{im}(B^t)$ is a sum of some of the eigenspaces V_0, V_1, V_d . Let \mathcal{G} and \mathcal{L} be as in the first part of the proof. We know on the one hand that $\mathbf{v}_G - \mathbf{v}_L$ is a non-zero vector in V_d and hence $\text{im}(B^t) \not\subseteq \text{im}(A^t)$. On the other hand, $\mathbf{v}_G + \mathbf{v}_L$ is a non-zero vector in $\text{im}(A^t)$ and since

$$A_1(\mathbf{v}_G + \mathbf{v}_L) = \left(\begin{bmatrix} d \\ 1 \end{bmatrix}_q - 2 \right) (\mathbf{v}_G + \mathbf{v}_L) + 2\mathbf{j},$$

the vector $\mathbf{v}_G + \mathbf{v}_L$ is not contained in V_0 or V_1 . We conclude that $\text{im}(B^t) = V_0 \perp V_1 \perp V_d$. \square

Now we present the characterisation theorem.

Theorem 3.28. Let \mathcal{P} be a polar space of type III of rank d over \mathbb{F}_q . Let \mathcal{L} be a set of generators of \mathcal{P} with characteristic vector χ . Let B be the incidence matrix of hyperbolic classes and generators of \mathcal{P} , and let K be the generator disjointness matrix of \mathcal{P} . Denote $\frac{|\mathcal{L}|}{\prod_{i=1}^{d-1} (q^i + 1)}$ by x . The four following statements are equivalent.

- (i) $\chi \in \text{im}(B^t)$.
- (ii) $\chi \in (\ker(B))^\perp$.
- (iii) For each fixed generator π of \mathcal{P} , the number of elements of \mathcal{L} disjoint from π equals $(x - (\chi)_\pi) q^{\binom{d}{2}}$.
- (iv) The vector $\chi - \frac{x}{q^d + 1} \mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-q^{\binom{d}{2}}$.

If \mathcal{P} admits a spread, then also the next two statements are equivalent to the previous ones.

- (v) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread \mathcal{S} of \mathcal{P} .
- (vi) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{P} , with \mathcal{C} a class of spreads which is a union of orbits under the action of an automorphism group that acts transitively on the pairs of disjoint generators of \mathcal{P} .

Proof. Statement (i) implies statement (ii) since $\text{im}(B^t) = (\ker(B))^\perp$. Now, we assume that (ii) is valid. Let π be a fixed generator and let χ_π be the characteristic vector of the set $\{\pi\}$. Let \mathcal{S}' be the set of all generators disjoint to π and denote its characteristic vector by $\chi_{\mathcal{S}'}$. By Lemma 3.26(ii) we can find a vector $\mathbf{v} \in \ker(B)$ such that

$$\chi_{\mathcal{S}'} = \mathbf{v} + q^{\binom{d}{2}} \left(\frac{1}{\prod_{i=1}^{d-1} (q^i + 1)} \mathbf{j} - \chi_\pi \right).$$

The number of elements of \mathcal{L} disjoint from π equals $|\mathcal{S}' \cap \mathcal{L}|$. We find

$$\begin{aligned} |\mathcal{S}' \cap \mathcal{L}| &= \langle \chi_{\mathcal{S}'}, \chi \rangle = \langle \mathbf{v}, \chi \rangle + q^{\binom{d}{2}} \left(\frac{1}{\prod_{i=1}^{d-1} (q^i + 1)} \langle \mathbf{j}, \chi \rangle - \langle \chi_\pi, \chi \rangle \right) \\ &= q^{\binom{d}{2}} \left(\frac{|\mathcal{L}|}{\prod_{i=1}^{d-1} (q^i + 1)} - (\chi)_\pi \right) = (x - (\chi)_\pi) q^{\binom{d}{2}}, \end{aligned}$$

since $\langle \mathbf{v}, \chi \rangle = 0$ by the assumption. This proves (iii).

By Theorem 3.1, statements (iii) and (iv) are equivalent. Now, we assume that (iv) is valid. We consider the association scheme of the generators of \mathcal{P} , with matrices $I = A_0, A_1, \dots, A_d = K$ and corresponding decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp \dots \perp V_d$, with Ω the set of generators of \mathcal{P} , using the ordering as in Section 2. By Lemma 2.15 there are two eigenspaces in this decomposition admitting $-q^{\binom{d}{2}}$ as eigenvalue for K , namely V_1 and V_d , since \mathcal{P} is of type III. It now follows from (iv) that $\chi - \frac{x}{q^{d+1}} \mathbf{j} \in V_1 \perp V_d$. Since $\mathbf{j} \in V_0$ we know that $\chi \in V_0 \perp V_1 \perp V_d$, and by Lemma 3.27, $V_0 \perp V_1 \perp V_d = \text{im}(B^t)$. So, statement (i) follows.

We have proved that the first four statements are equivalent. From now on we assume that \mathcal{P} admits a spread. We note that by Remark 3.4 the existence of a spread of \mathcal{P} implies the existence of a class \mathcal{C} as in statement (vi). This shows that statement (vi) is not an empty statement, which is important for the following argument. We show that (ii) implies (v) and that (vi) implies (iii). Since (v) clearly implies (vi), this shows that statements (v) and (vi) are both equivalent to the statements (i)-(iv).

We assume that (ii) is valid. Let \mathcal{S} be a spread of \mathcal{P} , with characteristic vector $\chi_{\mathcal{S}}$. By Lemma 3.26(i) we can find a vector $\mathbf{w} \in \ker(B)$ such that $\mathbf{v} = \chi_{\mathcal{S}} - \frac{1}{\prod_{i=1}^{d-1} (q^i + 1)} \mathbf{j} \in \ker(B)$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \chi, \chi_{\mathcal{S}} \rangle = \langle \chi, \mathbf{w} \rangle + \frac{1}{\prod_{i=1}^{d-1} (q^i + 1)} \langle \chi, \mathbf{j} \rangle = \frac{|\mathcal{L}|}{\prod_{i=1}^{d-1} (q^i + 1)} = x,$$

since $\langle \chi, \mathbf{w} \rangle = 0$ by the assumption. This proves (v).

By Lemma 3.3(ii) statement (vi) implies (iii). □

We can now define the Cameron-Liebler sets for polar spaces of type III, analogous to the definition for polar spaces of type I.

Definition 3.29. Let \mathcal{P} be a finite classical polar space of type III. A generator set \mathcal{L} that fulfills one of the statements in Theorem 3.28 (and consequently all of them) is called a *Cameron-Liebler set with parameter* $x = \frac{|\mathcal{L}|}{\prod_{i=1}^{d-1} (q^i + 1)}$.

The main difference between the polar spaces of type I and the polar spaces of type III is that the hyperbolic classes have taken the role of the points (or more precisely the point-pencils); the matrix B has taken the role of the matrix A .

Corollary 3.30. Let \mathcal{P} be a finite classical polar space of type III over \mathbb{F}_q of rank d . If \mathcal{L} is a Cameron-Liebler set with parameter x , then $|\mathcal{L}| = x \prod_{i=1}^{d-1} (q^i + 1)$.

The polar spaces $\mathcal{W}(4n + 1, q)$, q odd

In the previous subsections we defined Cameron-Liebler sets for all polar spaces except the symplectic polar spaces $\mathcal{W}(4n + 1, q)$, q odd. For these spaces we were not able to produce a characterisation result similar to Theorems 3.7, 3.15 and 3.28. This is the first open problem we want to pose. The main problem is that the image of the transposed point-generator incidence matrix does not correspond to an eigenspace of the generator disjointness matrix. We observed this non-correspondence also in the polar spaces of type III, however for those we could use the incidence matrix of hyperbolic classes and generators as a substitute, which we cannot do here, since no hyperbolic quadrics are embedded in $\mathcal{W}(4n + 1, q)$, q odd.

Recall from Table 2 that the symplectic polar spaces $\mathcal{W}(4n + 1, q)$, q odd, admit spreads. So, one could hope to prove a characterisation result (weaker than for the other polar spaces) including the disjointness statement, the eigenspace statement and the two spread statements. However, due to the absence of a substitute for the point-generator incidence matrix, we were not able to prove this in general. We remind the reader that the disjointness statement is the ‘central’ condition, which should always be present.

In this section we only handle the symplectic polar space $\mathcal{W}(5, q)$, q odd, for which we could prove a characterisation result. We start with a lemma about spreads in $\mathcal{W}(5, q)$, q odd.

Lemma 3.31. Let $\mathbb{R}^\Omega = V_0 \perp V_1 \perp V_2 \perp V_3$ be the eigenspace decomposition (using the classical order) related to the association scheme corresponding to $\mathcal{P} = \mathcal{W}(5, q)$, q odd. If the generator set \mathcal{S} , with characteristic vector χ , is a spread, then $\chi - \frac{q-1}{q^4-1}\mathbf{j} \in V_2$.

Proof. Given that \mathcal{S} is a spread, we count the number of generators (planes) that meet an element of \mathcal{S} in precisely a line:

$$(q^3 + 1)(q^2 + q + 1)q = (q^3 + 1)(q^2 + 1)(q + 1) - (q^3 + 1).$$

We conclude that all generators of \mathcal{P} that do not belong to \mathcal{S} meet an element of \mathcal{S} in a line. Let K be the generator disjointness matrix of \mathcal{P} . For any generator π of \mathcal{P} we now know that

$$(K\chi)_\pi = \begin{cases} q^3 & \pi \in \mathcal{S} \\ q^3 - q^2 & \pi \notin \mathcal{S} \end{cases}$$

since a generator not in \mathcal{S} meets one generator of \mathcal{S} in a line and q^2 generators of \mathcal{S} in a point. It follows that

$$K\chi = (q^3 - q^2)\mathbf{j} + q^2\chi.$$

We know that $K\mathbf{j} = q^6\mathbf{j}$ and thus

$$K\left(\chi - \frac{q-1}{q^4-1}\mathbf{j}\right) = (q^3 - q^2)\mathbf{j} + q^2\chi - q^6 \frac{q-1}{q^4-1}\mathbf{j} = q^2\left(\chi - \frac{q-1}{q^4-1}\mathbf{j}\right).$$

So, $\chi - \frac{q-1}{q^4-1}\mathbf{j}$ is an eigenvector of K with corresponding eigenvalue q^2 .

The eigenvalues of K corresponding to V_0, V_1, V_2 and V_3 are $q^6, -q^3, q^2$ and $-q^3$, respectively, see Section 2. Consequently, $\chi - \frac{q-1}{q^4-1}\mathbf{j}$ is contained in V_2 . \square

Using this lemma we prove the characterisation theorem.

Theorem 3.32. Let \mathcal{L} be a set of generators of $\mathcal{P} = \mathcal{W}(5, q)$, q odd, with characteristic vector χ . Let K be the generator disjointness matrix of \mathcal{P} and denote $\frac{|\mathcal{L}|}{(q+1)(q^2+1)}$ by x . The four following statements are equivalent.

- (i) For each fixed generator π of \mathcal{P} , the number of elements of \mathcal{L} disjoint from π equals $(x - (\chi)_\pi)q^3$.
- (ii) The vector $\chi - \frac{x}{q^3+1}\mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-q^3$.
- (iii) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread \mathcal{S} of \mathcal{P} .
- (iv) $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{P} , with \mathcal{C} a class of spreads which is a union of orbits under the action of an automorphism group that acts transitively on the pairs of disjoint generators of \mathcal{P}

Proof. Before starting we note that Remark 3.4 implies the existence of a class \mathcal{C} as in statement (iv). This shows that statement (iv) is not an empty statement, which is important for the proof.

By Theorem 3.1 statements (i) and (ii) are equivalent. Let $\mathbb{R}^\Omega = V_0 \perp V_1 \perp V_2 \perp V_3$ be the eigenspace decomposition (using the classical order) related to the association scheme corresponding to \mathcal{P} . Now, we assume that (ii) is valid: let \mathbf{v} be an eigenvector of K corresponding to the eigenvalue $-q^3$ such that $\chi = \mathbf{v} + \frac{x}{q^3+1}\mathbf{j}$. Then $\mathbf{v} \in V_1 \perp V_3$. Let \mathcal{S} be a spread of \mathcal{P} with characteristic vector $\chi_{\mathcal{S}}$. By Lemma 3.31 we can find a vector $\mathbf{w} \in V_2$ such that $\chi_{\mathcal{S}} = \mathbf{w} + \frac{q-1}{q^4-1}\mathbf{j}$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \chi, \chi_{\mathcal{S}} \rangle = \langle \chi, \mathbf{w} \rangle + \frac{q-1}{q^4-1} \langle \chi, \mathbf{j} \rangle = \frac{q-1}{q^4-1} \langle \mathbf{v}, \mathbf{j} \rangle + \frac{q-1}{q^4-1} \frac{x}{q^3+1} \langle \mathbf{j}, \mathbf{j} \rangle = x,$$

Here we used that $\langle \chi, \mathbf{w} \rangle = 0$ since $\chi \in V_0 \perp V_1 \perp V_3$ and $\mathbf{w} \in V_2$, and that $\langle \mathbf{v}, \mathbf{j} \rangle = 0$ since $\mathbf{v} \in V_1 \perp V_3$ and $\mathbf{j} \in V_0$. This proves (iii).

By Lemma 3.3(ii) statement (iv) implies (i). Since (iii) clearly implies (iv), all four statements are equivalent. \square

We can now define the Cameron-Liebler sets for the symplectic polar space $\mathcal{W}(5, q)$, q odd, analogously to the definitions for other polar spaces.

Definition 3.33. A generator set \mathcal{L} of $\mathcal{W}(5, q)$, q odd, that fulfills one of the statements in Theorem 3.32 (and consequently all of them) is called a *Cameron-Liebler set with parameter* $x = \frac{|\mathcal{L}|}{(q+1)(q^2+1)}$.

Corollary 3.34. If \mathcal{L} is a Cameron-Liebler set of $\mathcal{W}(5, q)$, q odd, with parameter x , then $|\mathcal{L}| = x(q+1)(q^2+1)$.

4 Properties and examples

The following properties of Cameron-Liebler sets can easily be proved.

Lemma 4.1. Let \mathcal{P} be a finite classical polar space of type I or III, or one class of generators of $\mathcal{Q}^+(2d-1, q)$, d even. If \mathcal{L} and \mathcal{L}' are Cameron-Liebler sets of \mathcal{P} with parameters x and x' respectively, then the following statements are valid.

- (i) $0 \leq x \leq q^{e+d-1} + 1$.
- (ii) The set of all generators not in \mathcal{L} is a Cameron-Liebler set of \mathcal{P} with parameter $q^{e+d-1} + 1 - x$.
- (iii) If $\mathcal{L} \cap \mathcal{L}' = \emptyset$, then $\mathcal{L} \cup \mathcal{L}'$ is a Cameron-Liebler set of \mathcal{P} with parameter $x + x'$.
- (iv) If $\mathcal{L}' \subset \mathcal{L}$, then $\mathcal{L} \setminus \mathcal{L}'$ is a Cameron-Liebler set of \mathcal{P} with parameter $x - x'$.

Now we present some examples of Cameron-Liebler sets.

Example 4.2. Let \mathcal{P} be a finite classical polar space of type I or III, or one class of generators of $\mathcal{Q}^+(2d-1, q)$, d even. The set \mathcal{L} of all generators of \mathcal{P} through a fixed point is a Cameron-Liebler set with parameter 1. Note that this is a point-pencil if \mathcal{P} is a polar space of type I or III.

For polar spaces of type I and a class of generators of $\mathcal{Q}^+(2d-1, q)$, d even, this is immediate as the incidence vector of \mathcal{L} is a row in the point-generator incidence matrix. For polar spaces of type III this follows from the observation that the image of the transposed point-generator incidence matrix is a subspace of the image of the transposed incidence matrix of hyperbolic classes and generators (see Lemmas 2.13 and 3.27).

Remark 4.3. A set of points in a polar space such that each generator contains at most one point of the set is called a *partial ovoid*; it is called an *ovoid* if each generator contains precisely one point of the set. It is immediate that an ovoid of a finite classical polar space of rank d with parameter e over \mathbb{F}_q contains $q^{d+e-1} + 1$ pairwise non-collinear points. Ovoids and partial ovoids of polar spaces are well-studied and many (non-)existence results are known. There is a close connection between ovoids and spreads. We refer to [12, Sections 3 and 4] for more background, details and results.

We note here that it follows from Lemma 4.1(iii) and Example 4.2 that a finite classical polar space of rank d with parameter e over \mathbb{F}_q that admits a partial ovoid of size $\left\lfloor \frac{q^{d+e-1}+1}{2} \right\rfloor$ has a Cameron-Liebler set for all possible parameter values. In particular all polar spaces that admit an ovoid have a Cameron-Liebler set for all possible parameter values.

Example 4.4. Let \mathcal{P} be a finite classical polar space of rank d with parameter e over \mathbb{F}_q and let \mathcal{P}' be a finite classical polar space of the same rank with parameter $e-1$ over \mathbb{F}_q that is embedded in \mathcal{P} , $e \geq 1$; all examples of such polar spaces \mathcal{P} and \mathcal{P}' are listed below. Let \mathcal{L} be the set of generators contained in \mathcal{P}' and let $\chi_{\mathcal{L}}$ be its characteristic vector. We denote the point-generator incidence matrix of \mathcal{P} by A and for any point $P \in \mathcal{P}$ we denote the corresponding row of A by \mathbf{v}_P^t , so \mathbf{v}_P is the characteristic vector of the point-pencil through P . Let \mathcal{H} be the set of points in \mathcal{P}' and let \mathcal{H}' be the set of points of \mathcal{P} not contained in \mathcal{P}' .

A generator of \mathcal{P} that is not contained in \mathcal{P}' has at most $\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$ points in common with \mathcal{P}' . However by double counting the tuples (P, π) with π a generator of \mathcal{P} that is not contained in \mathcal{P}' and $P \in \pi$ a point in \mathcal{P}' , we find that the generators of \mathcal{P} that are not contained in \mathcal{P}' , contain on average

$$\begin{aligned} & \begin{bmatrix} d \\ 1 \end{bmatrix}_q (q^{d+(e-1)-1} + 1) \cdot \frac{\prod_{i=0}^{d-2} (q^{i+e} + 1) - \prod_{i=0}^{d-2} (q^{i+e-1} + 1)}{\prod_{i=0}^{d-1} (q^{i+e} + 1) - \prod_{i=0}^{d-1} (q^{i+e-1} + 1)} \\ &= \begin{bmatrix} d \\ 1 \end{bmatrix}_q (q^{d+e-2} + 1) \cdot \frac{(q^{d+e-2} - q^{e-1}) \prod_{i=0}^{d-3} (q^{i+e} + 1)}{(q^{d+e-1} - q^{e-1}) \prod_{i=0}^{d-2} (q^{i+e} + 1)} \\ &= \begin{bmatrix} d \\ 1 \end{bmatrix}_q \frac{q^{d-1} - 1}{q^d - 1} = \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \end{aligned}$$

points of \mathcal{P}' . Consequently, any generator of \mathcal{P} that is not contained in \mathcal{P}' has precisely $\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$ points in common with \mathcal{P}' . Then,

$$\chi_{\mathcal{L}} = \frac{1}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q} \sum_{P \in \mathcal{H}} \mathbf{v}_P - \frac{\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q q^{d-1}} \sum_{P \in \mathcal{H}'} \mathbf{v}_P,$$

since each generator in \mathcal{L} contains $\begin{bmatrix} d \\ 1 \end{bmatrix}_q$ points of \mathcal{H} and no points of \mathcal{H}' , while every generator not in \mathcal{L} contains $\begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q$ points of \mathcal{H} and q^{d-1} points of \mathcal{H}' . Consequently, $\chi_{\mathcal{L}}$ is contained

in $\text{im}(A^t)$. So, if \mathcal{P} is a polar space of type I or type III, then \mathcal{L} is a Cameron-Liebler set with parameter $q^{e-1} + 1$.

We give all examples that arise from this construction.

- Consider the elliptic quadric $\mathcal{P} = \mathcal{Q}^-(2d+1, q)$, which is of type I. Any non-tangent hyperplane meets \mathcal{P} in a parabolic quadric $\mathcal{Q}(2d, q)$. The set of all generators in such an embedded parabolic quadric is a Cameron-Liebler set of \mathcal{P} with parameter $q + 1$.
- Consider the parabolic quadric $\mathcal{P} = \mathcal{Q}(2d, q)$, which is of type I if d is even and of type III if d is odd. Any non-tangent hyperplane meets \mathcal{P} in either a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ or an elliptic quadric $\mathcal{Q}^-(2d-1, q)$. The embedded hyperbolic quadrics have the same rank as \mathcal{P} . The set of all generators in such an embedded hyperbolic quadric is a Cameron-Liebler set of \mathcal{P} with parameter 2.
- Consider the symplectic variety $\mathcal{P} = \mathcal{W}(2d-1, q)$, q even, which is of type I if d is even and of type III if d is odd. By Remark 3.24 we can see that \mathcal{P} contains a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$ since the parabolic quadric $\mathcal{Q}(2d, q)$ contains hyperbolic quadrics $\mathcal{Q}^+(2d-1, q)$, see the previous bullet point. The set of all generators in such an embedded hyperbolic quadric is a Cameron-Liebler set of \mathcal{P} with parameter 2.
- Consider the Hermitian polar space $\mathcal{P} = \mathcal{H}(2d, q^2)$, which is of type I. Any non-tangent hyperplane meets \mathcal{P} in a Hermitian polar space $\mathcal{H}(2d-1, q^2)$. The set of all generators in such an embedded parabolic quadric is a Cameron-Liebler set of \mathcal{P} with parameter $q + 1$.

Example 4.5. Let \mathcal{P} be a finite classical polar space of type III. In Remark 3.25 we introduced the hyperbolic class. Any hyperbolic class of \mathcal{P} is a Cameron-Liebler set with parameter 1. This is immediate as the incidence vector of a hyperbolic class is a row in the incidence matrix of points and hyperbolic classes.

Example 4.6. Let \mathcal{P} be a finite classical polar space of type III of rank 3 over \mathbb{F}_q , hence $\mathcal{P} = \mathcal{W}(5, q)$ or $\mathcal{P} = \mathcal{Q}(6, q)$. Let π be a generator (a plane) and let \mathcal{L} be the set of all planes meeting π in a line or a plane. It is easy to see that all elements of \mathcal{L} meet each other. A plane $\tau \notin \mathcal{L}$ either meets π in a point or else has an empty intersection with π . If $\pi \cap \tau$ is a point, then τ meets π and the q planes through a line of π passing through $\pi \cap \tau$. If $\pi \cap \tau = \emptyset$, then through every point of τ there is a unique plane of \mathcal{L} . So, in both cases the number of elements of \mathcal{L} meeting τ equals $q^2 + q + 1$. By Theorem 3.28(iii) \mathcal{L} is a Cameron-Liebler set of \mathcal{P} with parameter 1.

Example 4.7. Let \mathcal{P} be one class of generators of the quadric $\mathcal{Q}^+(7, q)$. Let π be a generator (3-space) belonging to the other class and let \mathcal{L} be the set of generators of \mathcal{P} meeting π in a plane. It is immediate that the elements of \mathcal{L} pairwise meet. A generator $\tau \in \mathcal{P} \setminus \mathcal{L}$ meets π in a point. If τ and an element $\rho \in \mathcal{L}$ meet non-trivially, then the intersection $\tau \cap \rho$ must be contained in π . Hence, τ meets the $q^2 + q + 1$ elements of \mathcal{L} through a plane of π containing $\pi \cap \tau$. It follows from Theorem 3.15(iii) that \mathcal{L} is a Cameron-Liebler set of \mathcal{P} with parameter 1. We call this set of generators a *base-solid (with center π)*.

Recall that we defined the parameter x of a Cameron-Liebler set \mathcal{L} as a fraction in Definitions 3.8, 3.16 and 3.29. If the polar space admits a spread, each spread has x generators in common with \mathcal{L} , and so it is clear that x has to be an integer. Now we prove that x is always an integer.

Theorem 4.8. Let \mathcal{P} be a finite classical polar space of type I or III, or one class of generators of $\mathcal{Q}^+(2d-1, q)$, d even. Let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . Then $x \in \mathbb{N}$.

Proof. We present the proof for a finite classical polar space of type I. It is (very) similar for a polar space of type III and for a class of generators of $\mathcal{Q}^+(2d-1, q)$, d even. We denote the rank

of \mathcal{P} by d and its parameter by e . We denote the underlying finite field by \mathbb{F}_q . By Theorem 3.7(iii) the number of elements of \mathcal{L} that are disjoint to a given generator π equals

$$\frac{|\mathcal{L}| q^{\binom{d-1}{2}+e(d-1)}}{\prod_{i=0}^{d-2} (q^{i+e} + 1)} - \delta q^{\binom{d-1}{2}+e(d-1)},$$

with δ equal to 1 if $\pi \in \mathcal{S}$ and 0 if $\pi \notin \mathcal{S}$. Hence

$$\frac{|\mathcal{L}| q^{\binom{d-1}{2}+e(d-1)}}{\prod_{i=0}^{d-2} (q^{i+e} + 1)}$$

must be an integer. We know that $\gcd(q^a, q^b + 1) = 1$ for integers $a, b > 0$. Since $e \neq 0$ for polar spaces of type I, then $\gcd(q^{\binom{d-1}{2}+e(d-1)}, \prod_{i=0}^{d-2} (q^{i+e} + 1)) = 1$. So $\prod_{i=0}^{d-2} (q^{i+e} + 1)$ must be a divisor of $|\mathcal{L}|$ and hence x is an integer. \square

Lemma 4.9. Let \mathcal{P} be a finite classical polar space of type I of rank d with parameter e and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . The number of elements of \mathcal{L} meeting a generator π in a $(d-i-1)$ -space, $i = 0, \dots, d$, equals

$$\begin{cases} \left((x-1) \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q + q^{i+e-1} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q \right) q^{\binom{i-1}{2}+(i-1)e} & \text{if } \pi \in \mathcal{L} \\ x \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q q^{\binom{i-1}{2}+(i-1)e} & \text{if } \pi \notin \mathcal{L} \end{cases}.$$

Proof. Let χ be the characteristic vector of the generator set \mathcal{L} and denote the generator disjointness matrix of \mathcal{P} by K . By Theorem 3.7 we know that there is a vector \mathbf{v} in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}+e(d-1)}$ such that $\chi = \mathbf{v} + \frac{x}{q^{d+e-1}+1} \mathbf{j}$. Using the ordering as in Section 2, the vector \mathbf{v} is contained in V_1 , a common eigenspace of the matrices A_0, \dots, A_d of the association scheme related to \mathcal{P} , by Theorem 2.15. The matrix A_i is the incidence matrix of the relation R_i which describes whether the intersection dimension of two generators equals $d-i-1$ or not. Hence on the position corresponding to a generator π the vector $A_i \chi$ has the number of generators in \mathcal{L} meeting π in a $(d-i-1)$ -space. We find

$$\begin{aligned} A_i \chi &= A_i \mathbf{v} + \frac{x}{q^{d+e-1}+1} A_i \mathbf{j} = P_{1,i} \mathbf{v} + \frac{x}{q^{d+e-1}+1} P_{0,i} \mathbf{j} \\ &= \left(\begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{\binom{i}{2}+ie} - \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q q^{\binom{i-1}{2}+(i-1)e} \right) \mathbf{v} + \frac{x}{q^{d+e-1}+1} \begin{bmatrix} d \\ i \end{bmatrix}_q q^{\binom{i}{2}+ie} \mathbf{j} \\ &= \left(\begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{\binom{i}{2}+ie} - \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q q^{\binom{i-1}{2}+(i-1)e} \right) \left(\chi - \frac{x}{q^{d+e-1}+1} \mathbf{j} \right) + \frac{x}{q^{d+e-1}+1} \begin{bmatrix} d \\ i \end{bmatrix}_q q^{\binom{i}{2}+ie} \mathbf{j} \\ &= \frac{x}{q^{d+e-1}+1} q^{\binom{i-1}{2}+(i-1)e} \left(\begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{i+e-1} + \begin{bmatrix} d \\ i \end{bmatrix}_q q^{i+e-1} \right) \mathbf{j} \\ &\quad + \left(\begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{i+e-1} - \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q \right) q^{\binom{i-1}{2}+(i-1)e} \chi \\ &= \left(x \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q \mathbf{j} + \left(\begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{i+e-1} - \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q \right) \chi \right) q^{\binom{i-1}{2}+(i-1)e}. \end{aligned}$$

The lemma follows. \square

When applying the previous lemma for $i = 0$, we need to calculate $\binom{-1}{2} = \frac{(-1)(-2)}{2} = 1$. Obviously, we find in the lemma 1 if $\pi \in \mathcal{L}$ and 0 otherwise.

For the Cameron-Liebler sets of one class of generators of a hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, we can prove a similar result. Recall that two generators in the same class necessarily meet each other in a j -space for some $j \equiv d-1 \pmod{2}$ (see Remark 2.7).

Lemma 4.10. Let \mathcal{G} be a class of generators of the hyperbolic quadric $\mathcal{Q}^+(2d-1, q)$, d even, and let \mathcal{L} be a Cameron-Liebler set of \mathcal{G} with parameter x . The number of elements of \mathcal{L} meeting a generator π in a $(d-2i-1)$ -space, $i = 0, \dots, \frac{d}{2}$, equals

$$\begin{cases} \left((x-1) \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q + q^{2i-1} \begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q \right) q^{\binom{2i-1}{2}} & \text{if } \pi \in \mathcal{L} \\ x \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q q^{\binom{2i-1}{2}} & \text{if } \pi \notin \mathcal{L} \end{cases}.$$

Proof. Let χ be the characteristic vector of the generator set \mathcal{L} and denote the generator disjointness matrix of \mathcal{G} by K . By Theorem 3.15 we know that there is a vector \mathbf{v} in the eigenspace of K for the eigenvalue $-q^{\binom{d-1}{2}}$ such that $\chi = \mathbf{v} + \frac{x}{q^{d-1}+1} \mathbf{j}$. Using the ordering as in Remark 2.17, the vector \mathbf{v} is contained in V'_1 , a common eigenspace of the matrices $A'_0, \dots, A'_{\frac{d}{2}}$ of the association scheme related to \mathcal{G} , by Theorem 2.15. The matrix A'_i is the incidence matrix of the relation R'_i which describes whether the intersection dimension of two generators equals $d-2i-1$ or not. Hence on the position corresponding to a generator π the vector $A'_i \chi$ has the number of generators in \mathcal{L} meeting π in a $(d-2i-1)$ -space. We find

$$\begin{aligned} A'_i \chi &= A'_i \mathbf{v} + \frac{x}{q^{d-1}+1} A'_i \mathbf{j} = P_{1,2i} \mathbf{v} + \frac{x}{q^{d-1}+1} P_{0,2i} \mathbf{j} \\ &= \left(\begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q q^{\binom{2i}{2}} - \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q q^{\binom{2i-1}{2}} \right) \mathbf{v} + \frac{x}{q^{d-1}+1} \begin{bmatrix} d \\ 2i \end{bmatrix}_q q^{\binom{2i}{2}} \mathbf{j} \\ &= \left(\begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q q^{\binom{2i}{2}} - \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q q^{\binom{2i-1}{2}} \right) \left(\chi - \frac{x}{q^{d-1}+1} \mathbf{j} \right) + \frac{x}{q^{d-1}+1} \begin{bmatrix} d \\ 2i \end{bmatrix}_q q^{\binom{2i}{2}} \mathbf{j} \\ &= \frac{x}{q^{d-1}+1} q^{\binom{2i-1}{2}} \left(\begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q q^{2i-1} + \begin{bmatrix} d \\ 2i \end{bmatrix}_q q^{2i-1} \right) \mathbf{j} \\ &\quad + \left(\begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q q^{2i-1} - \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q \right) q^{\binom{2i-1}{2}} \chi \\ &= \left(x \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q \mathbf{j} + \left(\begin{bmatrix} d-1 \\ 2i \end{bmatrix}_q q^{2i-1} - \begin{bmatrix} d-1 \\ 2i-1 \end{bmatrix}_q \right) \chi \right) q^{\binom{2i-1}{2}}. \end{aligned}$$

The lemma follows. □

5 Generalised quadrangles

In Section 2 we introduced the generalised quadrangles (polar spaces of rank 2) separately from the polar spaces of rank at least three (see Definition 2.4) as for rank 2 there are also non-classical examples. In this section we will introduce the Cameron-Liebler sets for generalised quadrangles as line sets with specific properties. Recall that the dual of a generalised quadrangle arises by interchanging the points and lines. A spread of a generalised quadrangle is a set of lines such that any point is on precisely one of them.

Also in Section 2 we introduced the dual polar graph for classical polar spaces. For an arbitrary (not necessarily classical) generalised quadrangle we can define similarly a distance-regular graph whose vertices are the lines and such that two vertices are adjacent iff the corresponding lines meet each other in a point; it is in fact a strongly-regular graph. This graph gives rise to an association scheme. The following result is stated implicitly in [5, Section 6.5], but more clearly in [41, Theorem 6.3.3(i)]. However, in both cases the association scheme on the points has been described; the association scheme on the lines can easily be found by dualising.

Theorem 5.1. Let \mathcal{Q} be a generalised quadrangle of order (s, t) and consider its association scheme on the lines defined through the distance relations in the line graph (two vertices are adjacent if the lines meet in a point). The P -matrix of this scheme is given by

$$P = \begin{pmatrix} 1 & t(s+1) & st^2 \\ 1 & t-1 & -t \\ 1 & -s-1 & s \end{pmatrix}$$

where the columns correspond from left to right to the equal relation, the adjacency relation and the disjointness relation.

We first prove analogues for Lemmas 3.5 and 2.13.

Lemma 5.2. Let \mathcal{Q} be a generalised quadrangle of order (s, t) , and let A be the point-line incidence matrix of \mathcal{Q} . Let \mathcal{S} be a set of lines of \mathcal{Q} with characteristic vector χ .

- (i) The line set \mathcal{S} is a spread if and only if $\chi - \frac{1}{t+1}\mathbf{j} \in \ker(A)$.
- (ii) Let ℓ be a fixed line and let χ_ℓ be the characteristic vector of the set $\{\ell\}$. If \mathcal{S} is the set of all lines not meeting ℓ , then

$$\chi - \frac{t}{t+1}\mathbf{j} + t\chi_\ell \in \ker(A).$$

Proof. We denote the number of points of \mathcal{Q} by $n' = (s+1)(st+1)$, and the number of lines of \mathcal{Q} by $n = (t+1)(st+1)$. It is immediate that $A\mathbf{j}_n = (t+1)\mathbf{j}_{n'}$ since every row in A contains $t+1$ ones as this is the number of lines through a point.

Now, the set \mathcal{S} is a spread if and only if every point of \mathcal{Q} is contained in precisely one line of \mathcal{S} , hence if and only if $A\chi = \mathbf{j}_{n'}$. The first statement now follows from

$$\chi - \frac{1}{t+1}\mathbf{j}_n \in \ker(A) \quad \Leftrightarrow \quad A\chi = \frac{1}{t+1}A\mathbf{j}_n = \mathbf{j}_{n'}.$$

Let \mathbf{v}_ℓ be the characteristic vector of ℓ with the positions corresponding to the points of \mathcal{Q} . Note that $A\chi_\ell = \mathbf{v}_\ell$. If the set \mathcal{S} is the set of all lines not meeting ℓ , then $A\chi = t(\mathbf{j}_{n'} - \mathbf{v}_\ell)$ since every point not in ℓ is contained in t lines not meeting ℓ . The second statement now follows from

$$A\left(\chi - \frac{t}{t+1}\mathbf{j} + t\chi_\ell\right) = t(\mathbf{j}_{n'} - \mathbf{v}_\ell) - \frac{t}{t+1}(t+1)\mathbf{j}_{n'} + t\mathbf{v}_\ell = 0. \quad \square$$

Lemma 5.3. Let \mathcal{Q} be a generalised quadrangle of order (s, t) , and let A_0, A_1, A_2 be the incidence matrices of the corresponding association scheme as in Theorem 5.1. Consider the eigenspace decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp V_2$ related to this association scheme using the ordering as in Theorem 5.1, with Ω the set of all lines of \mathcal{Q} . Let A be the point-line incidence matrix of \mathcal{Q} . Then, $\text{im}(A^t) = V_0 \perp V_1$.

Proof. Let P be a point of \mathcal{Q} and let \mathbf{v}^t be the corresponding row of A . The vector \mathbf{v} is the characteristic vector of the set of lines through P (the point-pencil). So, the entry of $A_1\mathbf{v}$ corresponding to the line ℓ gives the number of lines through P which have a point in common with ℓ . It follows immediately that $A_1\mathbf{v} = t\mathbf{v} + (\mathbf{j} - \mathbf{v})$. We also know that $A_1\mathbf{j} = (s+1)t\mathbf{j}$.

This implies that

$$A_1\left(\mathbf{v} - \frac{1}{st+1}\mathbf{j}\right) = (t-1)\mathbf{v} + \mathbf{j} - \frac{st+t}{st+1}\mathbf{j} = (t-1)\left(\mathbf{v} - \frac{1}{st+1}\mathbf{j}\right),$$

and hence that $\mathbf{v} - \frac{1}{st+1}\mathbf{j}$ is contained in the eigenspace of A_1 for the eigenvalue $t-1$.

It follows directly from Theorem 5.1 that the eigenvalues of A_1 are pairwise different, hence that $\mathbf{v} - \frac{1}{st+1}\mathbf{j} \in V_1$. So, $\mathbf{v} \in V_0 \perp V_1$ since $V_0 = \langle \mathbf{j} \rangle$. Consequently, $\text{im}(A^t) \subseteq V_0 \perp V_1$.

Now, consider the matrix $A^t A$. This matrix has the same image as A^t . Furthermore $A^t A$ lies in the Bose-Mesner algebra of the association scheme, since the entry $(A^t A)_{\ell, \ell'}$ is the number of common points of any two lines ℓ and ℓ' , and so $A^t A = A_1 + (s+1)I$. By Lemma 2.3, this implies that $\text{im}(A^t) = \text{im}(A^t A)$ is a sum of eigenspaces V_i . It is clear that $\mathbf{j} \in \text{im}(A^t)$ because $A^t \mathbf{j} = (s+1)\mathbf{j}$, and that the rank of A is larger than 1 because A has two different rows. So, we must have $\text{im}(A^t) = V_0 \perp V_1$. \square

Using the previous lemmata we can now present a characterisation theorem for line sets in generalised quadrangles similar to Theorems 3.7, 3.15, 3.19, 3.28 and 3.32.

Theorem 5.4. Let \mathcal{Q} be a generalised quadrangle of order (s, t) and let \mathcal{L} be a set of lines of \mathcal{Q} with characteristic vector $\boldsymbol{\chi}$. Let A be the point-line incidence matrix of \mathcal{Q} , and let K be the line disjointness matrix of \mathcal{Q} . Denote $\frac{|\mathcal{L}|}{t+1}$ by x . The five following statements are equivalent.

- (i) $\boldsymbol{\chi} \in \text{im}(A^t)$.
- (ii) $\boldsymbol{\chi} \in (\ker(A))^\perp$.
- (iii) For each fixed line ℓ of \mathcal{Q} , the number of elements of \mathcal{L} disjoint from ℓ equals $(x - (\boldsymbol{\chi})_\ell)t$.
- (iv) For each fixed line ℓ of \mathcal{Q} , the number of elements of \mathcal{L} meeting ℓ in a point equals $x + (\boldsymbol{\chi})_\ell(t-1)$.
- (v) The vector $\boldsymbol{\chi} - \frac{x}{st+1}\mathbf{j}$ is contained in the eigenspace of K for the eigenvalue $-t$.

Proof. Statement (i) implies statement (ii) since $\text{im}(A^t) = (\ker(A))^\perp$. Now, we assume that (ii) is valid. Let ℓ be a fixed line and let $\boldsymbol{\chi}_\ell$ be the characteristic vector of the set $\{\ell\}$. Let \mathcal{S}' be the set of all lines not meeting ℓ and denote its characteristic vector by $\boldsymbol{\chi}_{\mathcal{S}'}$. By Lemma 5.2(ii) we can find a vector $\mathbf{v} \in \ker(A)$ such that

$$\boldsymbol{\chi}_{\mathcal{S}'} = \mathbf{v} + \frac{t}{t+1}\mathbf{j} - t\boldsymbol{\chi}_\ell.$$

The number of elements of \mathcal{L} disjoint from ℓ equals $|\mathcal{L} \cap \mathcal{S}'|$. We find

$$|\mathcal{S}' \cap \mathcal{L}| = \langle \boldsymbol{\chi}_{\mathcal{S}'}, \boldsymbol{\chi} \rangle = \langle \mathbf{v}, \boldsymbol{\chi} \rangle + \frac{t}{t+1} \langle \mathbf{j}, \boldsymbol{\chi} \rangle - t \langle \boldsymbol{\chi}_\ell, \boldsymbol{\chi} \rangle = \frac{t}{t+1} |\mathcal{L}| - t(\boldsymbol{\chi})_\ell = tx - t(\boldsymbol{\chi})_\ell,$$

since $\langle \mathbf{v}, \boldsymbol{\chi} \rangle = 0$ by the assumption. This proves (iii).

The entry on the position corresponding to a given line ℓ of the vector $K\boldsymbol{\chi}$ is the number of lines not meeting ℓ that are contained in \mathcal{L} . Assuming statement (iii), this number is $(x - (\boldsymbol{\chi})_\ell)t$, hence $K\boldsymbol{\chi} = t(x\mathbf{j} - \boldsymbol{\chi})$. The number of ones in a row of K equals the number of lines not meeting a given line, so $K\mathbf{j} = st^2\mathbf{j}$. It follows that

$$K \left(\boldsymbol{\chi} - \frac{x}{st+1}\mathbf{j} \right) = t(x\mathbf{j} - \boldsymbol{\chi}) - \frac{x}{st+1}st^2\mathbf{j} = -t \left(\boldsymbol{\chi} - \frac{x}{st+1}\mathbf{j} \right),$$

so the vector $\boldsymbol{\chi} - \frac{x}{st+1}\mathbf{j}$ is an eigenvector of K for the eigenvalue $-t$, which is statement (v). Now, we assume that (v) is valid. We consider the association scheme of the lines of \mathcal{Q} , with matrices I, A_1, K – here A_1 is the incidence matrix of the adjacency relation (meeting relation) – and corresponding decomposition $\mathbb{R}^\Omega = V_0 \perp V_1 \perp V_2$, with Ω the set of all lines of \mathcal{Q} , using the ordering as in Theorem 5.1. The eigenvalue of K corresponding to V_1 is $-t$. It also follows from this theorem that V_1 is the unique subspace in this decomposition admitting $-t$ as eigenvalue. It now follows from (iv) that $\boldsymbol{\chi} - \frac{x}{st+1}\mathbf{j} \in V_1$. Since $\mathbf{j} \in V_0$ we know that $\boldsymbol{\chi} \in V_0 \perp V_1$, and by Lemma 5.3, $V_0 \perp V_1 = \text{im}(A^t)$. So, statement (i) follows.

We have proved that the four statements (i), (ii), (iii) and (v) are equivalent. We now finish the proof by proving that statements (iii) and (iv) are equivalent. Let ℓ be a fixed line of \mathcal{Q} , let

A_ℓ be the number of lines in \mathcal{L} meeting ℓ in a point and let B_ℓ be the number of lines in \mathcal{L} disjoint to ℓ . It is immediate that $A_\ell + B_\ell = |\mathcal{L}| - (\chi)_\ell = x(t+1) - (\chi)_\ell$. Hence,

$$A_\ell = x + (\chi)_\ell(t-1) \quad \Leftrightarrow \quad B_\ell = (x - (\chi)_\ell)t,$$

which proves the equivalence of statements (iii) and (iv). \square

This theorem allows us to introduce Cameron-Liebler classes for arbitrary generalised quadrangles.

Definition 5.5. Let \mathcal{Q} be a generalised quadrangle. A line set \mathcal{L} that fulfills one of the statements in Theorem 5.4 (and consequently all of them) is called a *Cameron-Liebler set with parameter* $x = \frac{|\mathcal{L}|}{t+1}$.

Corollary 5.6. Let \mathcal{Q} be a generalised quadrangle of order (s, t) . If \mathcal{L} is a Cameron-Liebler set with parameter x , then $|\mathcal{L}| = x(t+1)$.

Compared with the characterisation theorems for Cameron-Liebler sets of polar spaces of rank at least 3, we see that there is no characterisation through spreads in Theorem 5.4. This is due to the fact that in general we have no information on the automorphism group of a generalised quadrangle, while we have Remark 3.4 for classical polar spaces.

For all generalised quadrangles that admit spreads we can prove that a spread and a Cameron-Liebler set have a constant number of lines in common, but the converse implication we can only prove for certain generalised quadrangles. We first need the following analogue to Lemma 3.3.

Lemma 5.7. Let \mathcal{Q} be a generalised quadrangle of order (s, t) that admits spreads, and let ℓ be a line of \mathcal{Q} . Let G be an automorphism group of \mathcal{P} that acts transitively on the pairs of disjoint lines of \mathcal{P} and let \mathcal{C} be a set of line spreads of \mathcal{P} which is a union of orbits of spreads under the action of G . Let \mathcal{L} be a set of lines of \mathcal{Q} with characteristic vector χ . If the intersection number $|\mathcal{L} \cap \mathcal{S}|$ equals x for every spread $\mathcal{S} \in \mathcal{C}$, then

- (i) $|\mathcal{L}| = x(t+1)$;
- (ii) the number of lines of \mathcal{L} disjoint to ℓ equals $(x - (\chi)_\ell)t$.

Proof. The proof is analogous to the proof of Lemma 3.3. \square

Theorem 5.8. Let \mathcal{Q} be a generalised quadrangle of order (s, t) and let \mathcal{L} be a Cameron-Liebler set with parameter x of \mathcal{Q} . For every spread \mathcal{S} of \mathcal{Q} , we have $|\mathcal{L} \cap \mathcal{S}| = x$.

Moreover, if \mathcal{Q} admits a spread and has an automorphism group G that acts transitively on the pairs of disjoint lines of \mathcal{P} and \mathcal{L} is a set of lines such that $|\mathcal{L} \cap \mathcal{S}| = x$ for every spread $\mathcal{S} \in \mathcal{C}$ of \mathcal{Q} , with \mathcal{C} a class of spreads which is a union of orbits under the action of G , then \mathcal{L} is a Cameron-Liebler set with parameter x .

Proof. We denote the point-line incidence matrix of \mathcal{Q} by A as in Theorem 5.4. Let \mathcal{S} be a spread of \mathcal{Q} , with characteristic vector $\chi_{\mathcal{S}}$. By Lemma 5.2(i) we can find a vector $\mathbf{w} \in \ker(A)$ such that $\chi_{\mathcal{S}} = \mathbf{w} + \frac{1}{t+1}\mathbf{j}$. Then

$$|\mathcal{L} \cap \mathcal{S}| = \langle \chi, \chi_{\mathcal{S}} \rangle = \langle \chi, \mathbf{w} \rangle + \frac{1}{t+1} \langle \chi, \mathbf{j} \rangle = \frac{|\mathcal{L}|}{t+1} = x,$$

since $\langle \chi, \mathbf{w} \rangle = 0$ by Theorem 5.4(ii) and Definition 5.5. This proves the first part of the theorem.

The second part of the proof follows from Lemma 5.7(ii), Theorem 5.4(iii) and Definition 5.5. \square

The Cameron-Liebler sets for generalised quadrangles which we just introduced analogously to the Cameron-Liebler sets for polar spaces, are closely related to tight sets of generalised quadrangles, introduced in [31]. We refer to [2] for a good introduction. For a generalised quadrangle we use P^\perp to denote the set of points collinear with P , the point P included.

Definition 5.9. A point set \mathcal{T} of a generalised quadrangle of order (s, t) is an i -tight set if for any point P we have

$$|P^\perp \cap \mathcal{T}| = \begin{cases} s + i & P \in \mathcal{T} \\ i & P \notin \mathcal{T} \end{cases}.$$

The following theorem is immediate.

Theorem 5.10. The line set \mathcal{L} in the generalised quadrangle \mathcal{Q} is a Cameron-Liebler set with parameter x if and only if the point set \mathcal{L}^D is an x -tight set in \mathcal{Q}^D .

Proof. This follows directly from Theorem 5.4 (v), Definition 5.5 and Definition 5.9. The difference between $x + (\chi)_\ell(t - 1)$ and $x + (\chi)_{\ell^D}t$ is a consequence from the fact the line itself is not included in Theorem 5.4 (v), but its dual is included in Definition 5.9. \square

We present a classification result on tight sets of generalised quadrangles. This yields an equivalent result for Cameron-Liebler sets of generalised quadrangles, but we will state it here in the context of tight sets. We first recall a known result.

Theorem 5.11 ([31, II.5]). Let \mathcal{Q} be a generalised quadrangle of order (s, t) . If \mathcal{T} is an i -tight set, with $i \leq s$, then a line of \mathcal{Q} is contained in \mathcal{T} or contains at most i points of \mathcal{T} .

Theorem 5.12. Let \mathcal{Q} be a generalised quadrangle of order (s, t) , with $s \geq t$. If \mathcal{T} is a tight set of \mathcal{Q} with parameter $x \leq \frac{s}{t} + 1$, then \mathcal{T} is the union of the point set of x disjoint lines, or $x = \frac{s}{t} + 1$ and the points of \mathcal{T} form a subquadrangle of \mathcal{Q} of order $(\frac{s}{t}, t)$.

Proof. We assume that \mathcal{T} is non-empty and does not contain a line, hence on every line there is a point not in \mathcal{T} . We consider the point $P \in \mathcal{T}$. We know that there are $x + s - 1$ points in \mathcal{T} collinear with P , not including P . By Theorem 5.11 there are at most $x - 1$ points of $\mathcal{T} \setminus \{P\}$ on a line through P since on this line there must be a point not in \mathcal{T} . Consequently,

$$x + s - 1 \leq (x - 1)(t + 1) \quad \Leftrightarrow \quad x \geq \frac{s}{t} + 1. \quad (1)$$

If $x < \frac{s}{t} + 1$, we find a contradiction. So, if \mathcal{T} is a non-empty tight set with parameter $x < \frac{s}{t} + 1$, then it contains the point set \mathcal{T}_ℓ of a line ℓ . It follows that $\mathcal{T} \setminus \mathcal{T}_\ell$ is a tight set with parameter $x - 1$, and moreover on each line meeting ℓ there is a point not in \mathcal{T} . We can proceed using induction. We find that \mathcal{T} is the union of x disjoint lines.

If $x = \frac{s}{t} + 1$, we can have equality in (1) if and only if on each line through a point of \mathcal{T} there are precisely x points of \mathcal{T} , equivalently on each line there are 0 or x points of \mathcal{T} . If \mathcal{T} is a tight set with parameter $x = \frac{s}{t} + 1$, then either it contains the point set of a line or else it does not. In the former case \mathcal{T} is the union of a line and a tight set with parameter $\frac{s}{t}$, hence the union of $\frac{s}{t} + 1$ lines. In the latter case we denote the set of lines containing $\frac{s}{t} + 1$ points of \mathcal{T} by \mathcal{L} . Now the lines of \mathcal{L} and the points of \mathcal{T} do form a subquadrangle of \mathcal{Q} of order $(\frac{s}{t}, t)$ since each point of \mathcal{T} lies on $t + 1$ lines of \mathcal{L} , on every line of \mathcal{L} there are $\frac{s}{t} + 1$ points of \mathcal{T} and $|\mathcal{T}| = (\frac{s}{t} + 1)(s + 1)$. \square

Remark 5.13. For the generalised quadrangles of order (s, s) this coincides with the classical result from [31, II.3 and II.4], which classified the i -tight sets with $i = 1, 2$ for all generalised quadrangles.

By the previous remark we will focus on generalised quadrangles of order (s, t) with $s > t$ in the discussion of Theorem 5.12.

Remark 5.14. Theorem 5.12 does not improve the known classification results for the classical generalised quadrangles with $s > t$, except for $\mathcal{H}(3, q^2)$, with $q = 2, 3, 4$. See Table 3 for an overview. For the non-classical generalised quadrangle $\mathcal{H}(4, q^2)^D$ of order (q^3, q^2) Theorem 5.12 gives the best known result.

The non-classical generalised quadrangle $T_3(O)$, with O an ovoid of $\text{PG}(3, q)$, has order (q, q^2) . For its construction we refer to [32, 3.1.2]. It is known that $T_3(O)$ is isomorphic to $\mathcal{Q}^-(5, q)$ if and

only if O is an elliptic quadric (see [32, 3.2.4]), so $T_3(O)^D$ is isomorphic to $\mathcal{H}(3, q^2)$ if and only if O is an elliptic quadric. It is a classical result that all ovoids in $\text{PG}(3, q)$, q odd, are elliptic quadrics (see [3, 30]), but in $\text{PG}(3, q)$, q even, ovoids that are not projectively equivalent to elliptic quadrics are known. For the generalised quadrangles $T_3(O)^D$, with O an ovoid that is not an elliptic quadric (hence not isomorphic to $\mathcal{H}(3, q^2)$), Theorem 5.12 gives the best classification result for tight sets.

In Table 3 we give an overview of the classification results for tight sets. Recall that the complement of an x -tight set in a generalised quadrangle of order (s, t) is an $(st - x + 1)$ -tight set, so we restrict to the results for $x \leq \frac{st+1}{2}$. We only include the generalised quadrangles for which there is a classification result for the tight sets with parameter at least 3 (as for generalised quadrangles the classification of x -tight sets with $x \leq 2$ is given in [31, II.3 and II.4]). Recall that $\mathcal{Q}(4, q) \cong \mathcal{W}(3, q)^D$, that $\mathcal{Q}(4, q) \cong \mathcal{Q}(4, q)^D$ iff q is even, and that $\mathcal{Q}^-(5, q) \cong \mathcal{H}(3, q^2)^D$ (see [32, Section 3.2]).

Table 3: Overview of the results on x -tight sets in generalised quadrangles, equivalently Cameron-Liebler sets. Here O is an ovoid in $\text{PG}(3, q)$, q even, that is not an elliptic quadric. The value ϵ_q is such that $q + \epsilon_q$ is the size of the smallest blocking set in $\text{PG}(2, q)$ not containing a line.

6 Classification results

In this section we present some classification results for Cameron-Liebler sets of generators in polar spaces. We obtain a strong result in the case of polar spaces of type I with $e \geq 1$.

In the arguments we will rely on results about Erdős-Ko-Rado sets of generators in polar spaces. The Erdős-Ko-Rado problem is a well-known problem in combinatorics, which finds his origins in [19], but which has been studied in many contexts. For background on the Erdős-Ko-Rado problem for generators of polar spaces we refer to [34, 41]. As we will see below it is closely related to the Cameron-Liebler problem.

Definition 6.1. An Erdős-Ko-Rado set of generators of a polar space is a set of pairwise not disjoint generators.

The following lemmata will be useful in the proof of the first classification theorem.

Lemma 6.2 ([34, Lemma 4]). Let π_1, π_2 and π_3 be pairwise non-disjoint generators in a classical polar space. The intersections $\pi_1 \cap \pi_2$ and $\pi_1 \cap \pi_3$ cannot be complementary subspaces of π_1 .

Lemma 6.3 ([25, Corollaries 5 and 12]). Let π and π' be two generators of a polar space \mathcal{P} that meet in a v -space.

- If $\mathcal{P} = \mathcal{Q}^+(2d+1, q)$ and $v \equiv d \pmod{2}$, the number of generators disjoint to both π and π' equals

$$q^{\frac{(d+v+2)(d+v)}{4} - \binom{v+1}{2}} \prod_{i=1}^{(d-v)/2} (q^{2i-1} - 1).$$

- If $\mathcal{P} = \mathcal{H}(2d+1, q^2)$, the number of generators disjoint to both π and π' equals

$$q^{(d+1)^2 - \binom{d-v+1}{2}} \prod_{i=1}^{d-v} (q^i + (-1)^i).$$

We present a first classification theorem, for Cameron-Liebler sets with parameter 1.

Theorem 6.4. Let \mathcal{P} be a finite classical polar space of type I or III, or one class of generators of $\mathcal{Q}^+(2d-1, q)$, d even, and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter 1.

- If \mathcal{P} is a polar space of type I, then \mathcal{L} is a point-pencil.
- If \mathcal{P} is one class of generators of $\mathcal{Q}^+(2d-1, q)$, d even, then \mathcal{L} is a point-pencil, or $d = 4$ and \mathcal{L} is a base-solid (described in Example 4.7).
- If \mathcal{P} is a polar space $\mathcal{Q}(4n+2, q)$ or a polar space $\mathcal{W}(4n+1, q)$, q even, then \mathcal{L} is a point-pencil or a hyperbolic class, or $n = 1$ and \mathcal{L} is given by Example 4.6.
- If $\mathcal{P} = \mathcal{W}(5, q)$, q odd, then \mathcal{L} is a point-pencil or \mathcal{L} is given by Example 4.6.

Proof. It follows immediately from Theorems 3.7(iii), 3.15(iii), 3.28(iii) and 3.32(i) that the elements of \mathcal{L} pairwise meet, hence \mathcal{L} is an Erdős-Ko-Rado set (which is not necessarily maximal). Moreover, we know that $|\mathcal{L}|$ is the size of a point-pencil of \mathcal{P} by Corollaries 3.9, 3.17, 3.30 and 3.34.

If \mathcal{P} is a generalised quadrangle (or one class of lines of $\mathcal{Q}^+(3, q)$), then any Erdős-Ko-Rado set is a subset of a point-pencil. The theorem is thus immediate in this case. Now, we assume that \mathcal{P} is an elliptic quadric $\mathcal{Q}^-(2d+1, q)$, $d \geq 3$, a parabolic quadric $\mathcal{Q}(2d, q)$, $d \geq 3$, one class of generators of a hyperbolic quadric $\mathcal{Q}^+(4n-1, q)$, $n \geq 2$, a symplectic variety $\mathcal{W}(4n-1, q)$, $n \geq 2$, a symplectic variety $\mathcal{W}(4n+1, q)$, q even, a symplectic variety $\mathcal{W}(5, q)$, q odd, a Hermitian variety $\mathcal{H}(4n-1, q^2)$, $n \geq 2$, or a Hermitian variety $\mathcal{H}(2d, q^2)$, $d \geq 3$. In these cases the theorem follows immediately from [34, Theorems 15, 21–24], summarized in [34, Section 9]. Note that we know by Examples 4.2, 4.5, 4.6 and 4.7 that the described Erdős-Ko-Rado sets are indeed Cameron-Liebler sets with parameter 1.

Now we assume that \mathcal{P} is either a hyperbolic quadric $\mathcal{Q}^+(4n+1, q)$ or a Hermitian variety $\mathcal{H}(4n+1, q)$, q a square. Note that \mathcal{P} is a classical polar space of type I with rank $d = 2n+1$. First we prove the following claim: for any generator π in \mathcal{L} the subset of \mathcal{L} of generators meeting π in precisely a point or in precisely a $(d-2)$ -space is the set of all generators through a fixed point P_π that meet the given generator in precisely a point, or the set of all generators through P_π that meet the given generator in precisely a $(d-2)$ -space, respectively.

Let π be an element of \mathcal{L} . Denote the subset of \mathcal{L} of generators meeting π in a $(d-2)$ -space by \mathcal{L}' and the subset of \mathcal{L} of generators meeting π in precisely a point by \mathcal{L}'' . By Lemma 4.9 we know that \mathcal{L}'' is non-empty. Let π' be a generator of \mathcal{L}'' meeting π in a point P . Then, by Lemma 6.2 any generator in \mathcal{L}' and π' meet non-trivially in π . Hence, all elements of \mathcal{L}' contain

P . By Lemma 4.9 we know that $|\mathcal{L}'| = \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q q^e$. So, \mathcal{L}' is the set of all generators of \mathcal{P} that meet π in a $(d-2)$ -space through P by Lemma 2.14. Now, again by Lemma 6.2 all elements of \mathcal{L}'' pass through P , and by Lemmas 2.14 and 4.9 we know that any generator meeting π in precisely P is contained in $\mathcal{L}'' \subset \mathcal{L}$. This finishes the proof of the claim with $P_\pi = P$.

We consider the case in which \mathcal{P} is a Hermitian variety $\mathcal{H} = \mathcal{H}(4n+1, q)$, q a square. Let π be an element of \mathcal{L} . We know that \mathcal{L} contains all generators through P_π meeting π in precisely a point. Assume that σ is a generator in \mathcal{L} that does not contain P_π . Let α be a $(4n-1)$ -space in the tangent space T_{P_π} to $\mathcal{H}(4n+1, q)$ at P_π , such that $P_\pi \notin \alpha$ and such that $\alpha \supset \sigma \cap T_{P_\pi} = \bar{\sigma}$. Denote the Hermitian variety $\alpha \cap \mathcal{H}$ by \mathcal{H}' . Note that $\bar{\sigma}$ is a generator of \mathcal{H}' . Furthermore, any generator τ of \mathcal{H} through P_π corresponds to the generator $\alpha \cap \tau$ of \mathcal{H}' ; let $\bar{\pi}$ be the generator of \mathcal{H}' corresponding to π . By Lemma 6.3 we know that there is a generator $\bar{\sigma}'$ of \mathcal{H}' disjoint to both $\bar{\pi}$ and $\bar{\sigma}$. The subspace $\sigma' = \langle \bar{\sigma}', P_\pi \rangle$ is a generator of \mathcal{H} meeting π in precisely the point P_π and disjoint to σ . By the above claim σ' is a generator in \mathcal{L} , however σ' is disjoint to σ , a contradiction as we assumed $\sigma \in \mathcal{L}$. We conclude that all generators in \mathcal{L} must contain the point P_π , hence \mathcal{L} is a point-pencil.

Finally, we consider the case in which \mathcal{P} is a hyperbolic quadric $\mathcal{Q} = \mathcal{Q}^+(4n+1, q)$. By Remark 4.5 we know that there are two classes of generators on \mathcal{Q} , which we will denote by Ω_1 and Ω_2 . Let π be an element of \mathcal{L} . Without loss of generality we can assume $\pi \in \Omega_1$. We know that \mathcal{L} contains all generators through P_π meeting π in precisely a point; all generators meeting π in precisely a point belong to Ω_1 . Let $\pi' \in \mathcal{L}$ be a generator such that $\pi \cap \pi'$ is the point P_π . Then $P_{\pi'} = P_\pi$ by the above claim since π is a generator in \mathcal{L} meeting π' in precisely a point.

Now, let α be a $(4n-1)$ -space in the tangent space T_{P_π} to $\mathcal{Q}^+(4n+1, q)$ at P_π , such that $P_\pi \notin \alpha$. Denote the hyperbolic quadric $\alpha \cap \mathcal{Q}$ by \mathcal{Q}' . Any generator τ of \mathcal{Q} through P_π corresponds to the generator $\alpha \cap \tau$ of \mathcal{Q}' ; let $\bar{\pi}$ be the generator of \mathcal{H}' corresponding to π . Consider a generator $\sigma \in \Omega_1$ containing P_π and let $\bar{\sigma}$ be its corresponding generator in \mathcal{Q}' . Since π and σ belong to the same generator class of \mathcal{Q} , the generators $\bar{\pi}$ and $\bar{\sigma}$ belong to the same class of \mathcal{Q}' . Hence, by Lemma 6.3 we know there is a generator $\bar{\sigma}'$ of \mathcal{Q}' disjoint to both $\bar{\pi}$ and $\bar{\sigma}$. The subspace $\sigma' = \langle \bar{\sigma}', P_\pi \rangle$ is a generator of \mathcal{Q} meeting π in precisely the point P_π , hence $\sigma' \in \mathcal{L}$. We observed before that $P_{\sigma'} = P_\pi$. So, since σ' meets σ in precisely $P_{\sigma'}$ (because $\bar{\sigma}$ and $\bar{\sigma}'$ are disjoint), σ is contained in \mathcal{L} .

So far, we conclude that the set \mathcal{L}_1 of all generators of the class Ω_1 through P_π is contained in \mathcal{L} . By the above claim we also know that \mathcal{L} contains generators of the class Ω_2 , namely those meeting π in a $(2n-1)$ -space containing P_π . Let ρ be such a generator of Ω_2 . Analogously, we can prove that the set \mathcal{L}_2 of all generators of the class Ω_2 through P_ρ is contained in \mathcal{L} . It is immediate that $|\mathcal{L}| = |\mathcal{L}_1| + |\mathcal{L}_2|$ as $|\mathcal{L}|$ is the size of a point-pencil. Consequently, $\mathcal{L} = \mathcal{L}_1 \cup \mathcal{L}_2$. If $P_\pi \neq P_\rho$, then \mathcal{L} contains clearly pairwise disjoint generators, contradicting that \mathcal{L} is an Erdős-Ko-Rado set. We conclude that $P_\pi = P_\rho$ and that \mathcal{L} is a point-pencil. \square

For the polar spaces of type I with $e \geq 1$ we extend the previous classification result. We classify all Cameron-Liebler sets with parameter at most $q^{e-1} + 1$. First we prove a lemma.

Lemma 6.5. Let \mathcal{P} be a finite classical polar space of type I of rank d and with parameter e , and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . Let π be a generator not in \mathcal{L} and let P be a point in π . Now, let z_j be the number of elements of \mathcal{L} meeting π in a j -space through P , $0 \leq j \leq d-2$. Then, $z_{d-j-2} = z_{d-2} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q q^{\binom{j}{2} + je}$, for $j = 0, \dots, d-2$.

Proof. We prove this lemma using induction. It is trivially fulfilled for $j = 0$, so we prove the induction step: assuming the lemma is true for all values up to (and including) $j-1$, we prove it for j .

By Lemma 4.9 we know that there are $x \begin{bmatrix} d-1 \\ j \end{bmatrix}_q q^{\binom{j}{2} + je}$ elements of \mathcal{L} meeting π in a $(d-j-2)$ -space, z_{d-j-2} of them through P . We want to count the elements of \mathcal{L} meeting π in a $(d-j-2)$ -space not through P . Denote the number of $(d-2)$ -spaces in π not through P that are contained

in i elements of \mathcal{L} by t_i . Then it is immediate that $\sum_{i \geq 0} t_i = q^{d-1}$ and that $\sum_{i \geq 0} it_i = x - z_{d-2}$. We perform a double counting of the following set:

$$\mathcal{T} = \{(\sigma, \alpha) \mid \sigma \in \mathcal{L}, \dim(\sigma \cap \pi) = d - j - 2, P \not\subseteq \sigma, \dim(\alpha) = d - 2, \alpha \subset \pi, P \not\subseteq \alpha, \sigma \cap \pi \subseteq \alpha\}.$$

For a generator $\sigma \in \mathcal{L}$ with $P \not\subseteq \sigma$ and $\dim(\sigma \cap \pi) = d - j - 2$ we can find q^j different $(d-2)$ -spaces in π passing through $\sigma \cap \pi$ and not containing P . Now, we look at a $(d-2)$ -space $\alpha \subset \pi$ not containing P . Denote the number of elements of \mathcal{L} through α by i . Let τ be a generator of \mathcal{P} meeting π in α . For a generator ρ meeting τ in a $(d-j-1)$ -space, there are three possibilities:

- $\rho \cap \pi$ is a $(d-j-2)$ -space contained in $\tau \cap \pi = \alpha$ ((ρ, τ, α) is of sort 1);
- $\rho \cap \pi$ is a $(d-j-1)$ -space contained in α ((ρ, τ, α) is of sort 2);
- $\rho \cap \pi$ is a $(d-j)$ -space that meets α in a $(d-j-1)$ -space ((ρ, τ, α) is of sort 3).

By Lemma 4.9 we know the number of elements of \mathcal{L} meeting τ in a $(d-j-1)$ -space, hence the number of tuples (ρ, τ, α) with α a $(d-2)$ -space in π not through P , τ a generator meeting π in α and ρ an element of \mathcal{L} meeting τ in a $(d-j-1)$ -space:

$$\begin{aligned} & \sum_{i \geq 0} t_i \left[i \left((x-1) \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q + q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q \right) q^{\binom{j-1}{2} + (j-1)e} + (q^e - i)x \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q q^{\binom{j-1}{2} + (j-1)e} \right] \\ &= q^{\binom{j-1}{2} + (j-1)e} \left(xq^e \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \sum_{i \geq 0} t_i + \left(q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) \sum_{i \geq 0} it_i \right) \\ &= q^{\binom{j-1}{2} + (j-1)e} \left(xq^{d+e-1} \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q + \left(q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) (x - z_{d-2}) \right). \end{aligned}$$

We denote the set of these tuples (ρ, τ, α) by \mathcal{T}' . Note that for any tuple $(\rho, \alpha) \in \mathcal{T}$ the generator $\tau \supset \alpha$, meeting ρ in a $(d-j-1)$ -space is uniquely determined; hence for any tuple $(\rho, \alpha) \in \mathcal{T}$ there is a unique tuple $(\rho, \tau, \alpha) \in \mathcal{T}'$ of sort 1.

If $(\rho, \tau, \alpha) \in \mathcal{T}'$ is of sort 1, then $(\rho, \alpha) \in \mathcal{T}$. If $(\rho, \tau, \alpha) \in \mathcal{T}'$ is of sort 2, then $(\rho, \alpha) \notin \mathcal{T}$ and there are $q^e - 1$ choices for τ given ρ and α . The number of tuples $(\rho, \tau, \alpha) \in \mathcal{T}'$ of sort 2 is

$$\left(x \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q q^{\binom{j-1}{2} + (j-1)e} - z_{d-j-1} \right) q^{j-1} (q^e - 1),$$

since there are $x \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q q^{\binom{j-1}{2} + (j-1)e} - z_{d-j-1}$ elements of \mathcal{L} meeting π in a $(d-j-1)$ -space not through P by Lemma 4.9 and there are q^{j-1} different $(d-2)$ -spaces in π not through P , containing a given $(d-j-1)$ -space.

If $(\rho, \tau, \alpha) \in \mathcal{T}'$ is of sort 3, then $(\rho, \alpha) \notin \mathcal{T}$. To count the number of these tuples $(\rho, \tau, \alpha) \in \mathcal{T}'$ of sort 3 we must distinguish between the generators ρ that meet P and the generators ρ that do not. The total number of generators ρ such that $\dim(\rho \cap \pi) = d-j$ equals $x \begin{bmatrix} d-1 \\ j-2 \end{bmatrix}_q q^{\binom{j-2}{2} + (j-2)e}$ by Lemma 4.9, of which z_{d-j} pass through P . If ρ passes through P , there are q^{d-1} choices for α and for a given α and ρ precisely q^e choices for τ . If ρ does not pass through P , there are $q^{d-1} - q^{j-2}$ choices for α , and for a given α and ρ there are precisely q^e choices for τ . The number of tuples $(\rho, \tau, \alpha) \in \mathcal{T}'$ of sort 3 hence equals

$$\begin{aligned} & z_{d-j} q^{d-1} q^e + \left(x \begin{bmatrix} d-1 \\ j-2 \end{bmatrix}_q q^{\binom{j-2}{2} + (j-2)e} - z_{d-j} \right) (q^{d-1} - q^{j-2}) q^e \\ &= z_{d-j} q^{j-2} q^e + x \begin{bmatrix} d-1 \\ j-2 \end{bmatrix}_q q^{\binom{j-2}{2} + (j-2)e} (q^{d-1} - q^{j-2}) q^e. \end{aligned}$$

Consequently,

$$\begin{aligned}
|\mathcal{T}| &= q^{\binom{j-1}{2}+(j-1)e} \left(xq^{d+e-1} \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q + \left(q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) (x - z_{d-2}) \right) \\
&\quad - \left(x \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q q^{\binom{j-1}{2}+(j-1)e} - z_{d-j-1} \right) q^{j-1}(q^e - 1) \\
&\quad - z_{d-j} q^{j-2} q^e - x \begin{bmatrix} d-1 \\ j-2 \end{bmatrix}_q q^{\binom{j-2}{2}+(j-2)e} (q^{d-1} - q^{j-2}) q^e \\
&= xq^{\binom{j-1}{2}+(j-1)e} \left(q^{j+e-1} \left(q^{d-j} \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q + \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) + (q^{j-1} - 1) \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right. \\
&\quad \left. - (q^{d-j+1} - 1) \begin{bmatrix} d-1 \\ j-2 \end{bmatrix}_q \right) - q^{\binom{j-1}{2}+(j-1)e} \left(q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) z_{d-2} \\
&\quad + z_{d-j-1} q^{j-1} (q^e - 1) - z_{d-j} q^{j-2} q^e \\
&\stackrel{IH}{=} xq^{\binom{j}{2}+je} q^j \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - q^{\binom{j-1}{2}+(j-1)e} \left(q^{j+e-1} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) z_{d-2} \\
&\quad + z_{d-2} \begin{bmatrix} d-2 \\ j-1 \end{bmatrix}_q q^{\binom{j-1}{2}+(j-1)e} q^{j-1} (q^e - 1) - z_{d-2} \begin{bmatrix} d-2 \\ j-2 \end{bmatrix}_q q^{\binom{j-2}{2}+(j-2)e} q^{j-2} q^e \\
&= xq^{\binom{j}{2}+je} q^j \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - z_{d-2} q^{\binom{j-1}{2}+(j-1)e} \left(q^{j+e-1} \left(\begin{bmatrix} d-1 \\ j \end{bmatrix}_q - \begin{bmatrix} d-2 \\ j-1 \end{bmatrix}_q \right) \right. \\
&\quad \left. + \left(q^{j-1} \begin{bmatrix} d-2 \\ j-1 \end{bmatrix}_q + \begin{bmatrix} d-2 \\ j-2 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ j-1 \end{bmatrix}_q \right) \right) \\
&= xq^{\binom{j}{2}+je} q^j \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - z_{d-2} q^{\binom{j}{2}+je} q^j \begin{bmatrix} d-2 \\ j \end{bmatrix}_q.
\end{aligned}$$

We find that the number of generators $\sigma \in \mathcal{L}$, with $P \notin \sigma$ and $\dim(\sigma \cap \pi) = d - j - 2$, equals

$$\frac{|\mathcal{T}|}{q^j} = xq^{\binom{j}{2}+je} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - z_{d-2} q^{\binom{j}{2}+je} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q.$$

Now it follows from the arguments at the beginning of the proof that

$$\begin{aligned}
x \begin{bmatrix} d-1 \\ j \end{bmatrix}_q q^{\binom{j}{2}+je} &= z_{d-j-2} + xq^{\binom{j}{2}+je} \begin{bmatrix} d-1 \\ j \end{bmatrix}_q - z_{d-2} q^{\binom{j}{2}+je} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q \\
\Leftrightarrow z_{d-j-2} &= z_{d-2} q^{\binom{j}{2}+je} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q.
\end{aligned}$$

This finishes the proof of the induction step. \square

Before presenting the main classification theorem, we first mention a characterisation result about embedded polar spaces.

Theorem 6.6 ([9, Theorem 1.7]). Let \mathcal{P} be a finite classical polar space of rank $d \geq 3$ and with parameter $e \geq 1$, embedded in a projective space over \mathbb{F}_q and let \mathcal{S} be a set of generators of \mathcal{P} such that

- (i) for every $i = 0, \dots, d$ the number of elements of \mathcal{S} meeting a generator π in a $(d-i-1)$ -space

equals

$$\begin{cases} \left(\left(\begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q + q^i \begin{bmatrix} d-1 \\ i \end{bmatrix}_q \right) q^{\binom{i-1}{2} + ie-1} & \text{if } \pi \in \mathcal{S} \\ (q^{e-1} + 1) \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q q^{\binom{i-1}{2} + (i-1)e} & \text{if } \pi \notin \mathcal{S} \end{cases};$$

(ii) for every point P of \mathcal{P} there is a generator $\pi \notin \mathcal{S}$ through P ;

(iii) for every point P of \mathcal{P} and every generator $\pi \notin \mathcal{S}$ through P , there are either $(q^{e-1} + 1) \begin{bmatrix} d-2 \\ j \end{bmatrix}_q q^{\binom{j}{2} + je}$ generators of \mathcal{L} through P meeting τ in a $(d-j-2)$ -space, for all $j = 0, \dots, d-2$, or there are no generators of \mathcal{L} through P meeting τ in a $(d-j-2)$ -space, for all $j = 0, \dots, d-2$.

Then \mathcal{S} is the set of generators of a classical polar space of rank d and with parameter $e-1$ embedded in \mathcal{P} .

Theorem 6.7. Let \mathcal{P} be a finite classical polar space of type I of rank d and with parameter $e \geq 1$, and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . If $x \leq q^{e-1} + 1$, then \mathcal{L} is the union of x point-pencils whose vertices are pairwise non-collinear or $x = q^{e-1} + 1$ and \mathcal{L} is the set of generators of an embedded polar space of rank d and with parameter $e-1$ (Example 4.4).

Proof. We proceed by induction on x . The statement is trivially fulfilled for $x = 0$, so we consider the case $x > 0$. Let $\pi \in \mathcal{L}$ be a generator. By Lemma 4.9 we know that there are

$$\left((x-1) \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q + q^{i+e-1} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q \right) q^{\binom{i-1}{2} + (i-1)e}$$

elements of \mathcal{L} meeting π in a $(d-i-1)$ -space. So, the number of tuples (Q, σ) with $\sigma \in \mathcal{L}$ and Q a point in $\pi \cap \sigma$ equals

$$N = \sum_{i=0}^{d-1} \left((x-1) \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q + q^{i+e-1} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q \right) q^{\binom{i-1}{2} + (i-1)e} \begin{bmatrix} d-i \\ 1 \end{bmatrix}_q$$

where the term for $i = 0$ corresponds to the tuples with $\sigma = \pi$, so

$$\begin{aligned} N &= \frac{x-1}{q-1} \sum_{i=0}^{d-1} q^{\binom{i-1}{2} + (i-1)e} \begin{bmatrix} d-1 \\ i-1 \end{bmatrix}_q (q^{d-i} - 1) + \frac{1}{q-1} \sum_{i=0}^{d-1} q^{\binom{i}{2} + ie} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q (q^{d-i} - 1) \\ &= \frac{x-1}{q-1} \sum_{i=0}^{d-1} q^{\binom{i}{2} + ie} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q (q^{d-i-1} - 1) + \frac{1}{q-1} \sum_{i=0}^{d-1} q^{\binom{i}{2} + ie} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q (q^{d-i} - 1) \\ &= \frac{x-1}{q-1} \left[q^{d-1} \sum_{i=0}^{d-1} q^{\binom{i}{2}} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{i(e-1)} - \sum_{i=0}^{d-1} q^{\binom{i}{2}} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{ie} \right] \\ &\quad + \frac{1}{q-1} \left[q^d \sum_{i=0}^{d-1} q^{\binom{i}{2}} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{i(e-1)} - \sum_{i=0}^{d-1} q^{\binom{i}{2}} \begin{bmatrix} d-1 \\ i \end{bmatrix}_q q^{ie} \right] \\ &\stackrel{\text{Lem. 2.8}}{=} \frac{x-1+q}{q-1} q^{d-1} \prod_{j=0}^{d-2} (q^{j+e-1} + 1) - \frac{x}{q-1} \prod_{j=0}^{d-2} (q^{j+e} + 1) \\ &= \left(\frac{x}{q-1} (q^{d-1}(q^{e-1} + 1) - (q^{d+e-2} + 1)) + q^{d-1}(q^{e-1} + 1) \right) \prod_{j=0}^{d-3} (q^{j+e} + 1) \\ &= \left(x \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q + q^{d-1}(q^{e-1} + 1) \right) \prod_{j=0}^{d-3} (q^{j+e} + 1). \end{aligned}$$

It is immediate that there is a point $P \in \pi$ which is contained in at least $N \begin{bmatrix} d \\ 1 \end{bmatrix}_q^{-1}$ of these tuples, hence in at least $N \begin{bmatrix} d \\ 1 \end{bmatrix}_q^{-1}$ elements of \mathcal{L} meeting π non-trivially. Assume there is a generator τ through P that is not contained in \mathcal{L} . Let z_j be the number of elements of \mathcal{L} meeting τ in a j -space through P , $0 \leq j \leq d-2$. By Lemma 6.5 $z_{d-j-2} = z_{d-2} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q q^{\binom{j}{2}+je}$, for $j = 0, \dots, d-2$. So, the number of elements of \mathcal{L} meeting τ in a subspace containing P equals

$$\sum_{j=0}^{d-2} z_{d-j-2} = \sum_{j=0}^{d-2} z_{d-2} \begin{bmatrix} d-2 \\ j \end{bmatrix}_q q^{\binom{j}{2}+je} \stackrel{\text{Lem. 2.8}}{=} z_{d-2} \prod_{j=0}^{d-3} (q^{j+e} + 1).$$

It follows that

$$\frac{\left(x \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q + q^{d-1}(q^{e-1} + 1) \right) \prod_{j=0}^{d-3} (q^{j+e} + 1)}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q} \leq z_{d-2} \prod_{j=0}^{d-3} (q^{j+e} + 1) \leq x \prod_{j=0}^{d-3} (q^{j+e} + 1).$$

Note that $z_{d-2} \leq x$ by Lemma 4.9. Now,

$$\begin{aligned} & \frac{\left(x \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q + q^{d-1}(q^{e-1} + 1) \right) \prod_{j=0}^{d-3} (q^{j+e} + 1)}{\begin{bmatrix} d \\ 1 \end{bmatrix}_q} \leq x \prod_{j=0}^{d-3} (q^{j+e} + 1) \\ \Leftrightarrow & \quad q^{d-1}(q^{e-1} + 1) \leq x \left(\begin{bmatrix} d \\ 1 \end{bmatrix}_q - \begin{bmatrix} d-1 \\ 1 \end{bmatrix}_q \right) \\ \Leftrightarrow & \quad q^{e-1} + 1 \leq x. \end{aligned}$$

If $x < q^{e-1} + 1$, then this is a contradiction. Consequently, in this case all generators through P are contained in \mathcal{L} ; let \mathcal{L}' be the point-pencil with vertex P . Then $\mathcal{L} \setminus \mathcal{L}'$ is a Cameron-Liebler set of \mathcal{P} with parameter $x-1$. This finishes the induction argument. Note that no element of $\mathcal{L} \setminus \mathcal{L}'$ contains P , hence none of the vertices of the $x-1$ point-pencils in $\mathcal{L} \setminus \mathcal{L}'$ is collinear with P .

If $x = q^{e-1} + 1$, then either all of the previous inequalities are equalities or some of them are not. In the latter case, we can repeat the argument of the case $x < q^{e-1} + 1$ and we find the union of x point-pencils with pairwise non-collinear vertices. In the former case we find that \mathcal{L} is a set of $\prod_{j=-1}^{d-2} (q^{j+e} + 1) = \prod_{j=0}^{d-1} (q^{j+(e-1)} + 1)$ generators admitting the relations of Lemma 4.9 for $x = q^{e-1} + 1$ such that for any point there is a generator not in \mathcal{L} through it and such that for any point P and generator $\tau \notin \mathcal{L}$ containing P there are either $(q^{e-1} + 1) \begin{bmatrix} d-2 \\ j \end{bmatrix}_q q^{\binom{j}{2}+je}$ generators of \mathcal{L} through P meeting τ in a $(d-j-2)$ -space, for all $j = 0, \dots, d-2$, or there are no generators of \mathcal{L} through P meeting τ in a $(d-j-2)$ -space, for all $j = 0, \dots, d-2$. By Theorem 6.6 \mathcal{L} has to be a polar space of rank d and with parameter $e-1$ embedded in \mathcal{P} . \square

The previous result deals with Cameron-Liebler sets in polar spaces of type I. Now we look at the hyperbolic quadrics of even rank. The classification of the Cameron-Liebler sets in (one class of generators of) $\mathcal{Q}^+(3, q)$ is trivial, so we will look at Cameron-Liebler sets in one class of generators of $\mathcal{Q}^+(7, q)$.

We recall from Theorem 2.16 that the automorphism group of a finite classical polar space acts transitively on pairs of disjoint generators. We will now look at triples of pairwise disjoint

generators. The following result seems to be known among geometers, but the authors did not find direct proof. It does follow from [8, Proposition 8 and Remark 9]. However, the proof there uses Segre varieties. For sake of completeness we will provide here a direct proof.

Lemma 6.8. The automorphism group of $\mathcal{Q}^+(4n-1, q)$, $n \geq 1$, acts transitively on triples of pairwise disjoint generators.

Proof. Without loss of generality we can assume that $\mathcal{Q} = \mathcal{Q}^+(4n-1, q)$ is given by the quadratic form $Q(x_0, \dots, x_{4n-1}) = x_0x_{2n} + \dots + x_{2n-1}x_{4n-1}$, represented by the matrix $\begin{pmatrix} 0 & I \\ 0 & 0 \end{pmatrix}$, where all blocks are $(2n \times 2n)$ -matrices. Let G be the collineation group (automorphism group) of \mathcal{Q} ; its elements are given by a $(4n \times 4n)$ -matrix and an \mathbb{F}_q -automorphism. Let $H \leq G$ be the subgroup of isometries of \mathcal{Q} , the collineations whose corresponding field automorphism is trivial. We will prove that for four pairwise disjoint generators $\pi_1, \pi_2, \pi_3, \pi_4$ there is an element of H that fixes π_1 and π_2 , and that maps π_3 onto π_4 . Since, by Theorem 2.16, G acts transitively on the pairs of pairwise disjoint generators of \mathcal{Q} , we can choose $\pi_1 = \text{col}\left(\begin{pmatrix} I \\ 0 \end{pmatrix}\right)$ and $\pi_2 = \text{col}\left(\begin{pmatrix} 0 \\ I \end{pmatrix}\right)$.

The elements of H that fix both π_1 and π_2 are given by the matrices $A = \begin{pmatrix} A_1 & 0 \\ 0 & A_2 \end{pmatrix}$, with A_1 and A_2 non-singular $(2n \times 2n)$ -matrices. For A to be an isometry, moreover we must have

$$\begin{pmatrix} 0 & I \\ 0 & 0 \end{pmatrix} = \begin{pmatrix} A_1 & 0 \\ 0 & A_2 \end{pmatrix} \begin{pmatrix} 0 & I \\ 0 & 0 \end{pmatrix} \begin{pmatrix} A_1 & 0 \\ 0 & A_2 \end{pmatrix}^t = \begin{pmatrix} 0 & A_1A_2^t \\ 0 & 0 \end{pmatrix},$$

hence $A_1A_2^t = I$. Any generator that is disjoint to both π_1 and π_2 can be described as $\text{col}\left(\begin{pmatrix} I \\ X \end{pmatrix}\right)$ with X a non-singular $(2n \times 2n)$ -matrix. A $(2n-1)$ -space $\text{col}\left(\begin{pmatrix} I \\ X \end{pmatrix}\right)$ is a generator of \mathcal{Q} if and only if

$$\begin{pmatrix} I & X^t \\ I & 0 \end{pmatrix} \begin{pmatrix} 0 & I \\ I & 0 \end{pmatrix} \begin{pmatrix} I \\ X \end{pmatrix} = 0 \quad \Leftrightarrow \quad X + X^t = 0,$$

where X , I and 0 are $(2n \times 2n)$ -matrices. It follows that X is an alternating matrix. Note that $\begin{pmatrix} 0 & I \\ I & 0 \end{pmatrix}$ is the matrix of the bilinear form associated with Q .

Let C and C' be the non-singular alternating $(2n \times 2n)$ -matrices such that $\pi_3 = \text{col}\left(\begin{pmatrix} I \\ C \end{pmatrix}\right)$ and $\pi_4 = \text{col}\left(\begin{pmatrix} I \\ C' \end{pmatrix}\right)$. Since two non-singular alternating matrices of the same dimension are conjugate (up to isomorphism there is only one symplectic polar space of a given rank), there is a non-singular matrix D such that $C' = DCD^t$. Now,

$$\begin{pmatrix} (D^t)^{-1} & 0 \\ 0 & D \end{pmatrix} \begin{pmatrix} I \\ C \end{pmatrix} = \begin{pmatrix} (D^t)^{-1} \\ DC \end{pmatrix} \quad \text{and} \quad \text{col}\left(\begin{pmatrix} (D^t)^{-1} \\ DC \end{pmatrix}\right) = \text{col}\left(\begin{pmatrix} (D^t)^{-1}D^t \\ DCD^t \end{pmatrix}\right) = \text{col}\left(\begin{pmatrix} I \\ C' \end{pmatrix}\right).$$

So, the isometry defined by the matrix $\begin{pmatrix} (D^t)^{-1} & 0 \\ 0 & D \end{pmatrix}$ maps π_3 onto π_4 , and it fixes both π_1 and π_2 . This finishes the proof. \square

From [8, Proposition 4 and Remark 5] the analogous statement for the Hermitian varieties $\mathcal{H}(2d-1, q^2)$ follows. The proof in [8] also uses Segre varieties, but it is probably possible to give a proof similar to the above. We do not go into detail because we do not need this result in this paper. It is immediate that an analogous result cannot hold for the polar spaces $\mathcal{Q}^+(4n+1, q)$, $n \geq 1$, $\mathcal{Q}(4n, q)$, $n \geq 1$, $\mathcal{Q}^-(2d+1, q)$, $d \geq 1$, and $\mathcal{H}(2d, q^2)$, $d \geq 1$.

In the next lemmata we will consider those hyperbolic quadrics $\mathcal{Q}^+(4n-1, q)$ that admit spreads. Recall from Table 2 that we know that the hyperbolic quadric $\mathcal{Q}^+(4n-1, q)$ admits a spread if q is even. If q is odd, it admits a spread in case $n=1$ or in case $n=2$ and q is prime or $q \not\equiv 1 \pmod{3}$; if q is odd and $n \geq 3$, or if $q \equiv 1 \pmod{3}$ is non-prime and odd and $n=2$, no existence or non-existence results are known, up to the knowledge of the authors. Also, recall that two disjoint generators in $\mathcal{Q}^+(4n-1, q)$ belong to the same class.

We first prove two lemmas.

Lemma 6.9. Let \mathcal{P} be one class of generators of a hyperbolic quadric $\mathcal{Q}^+(4n-1, q)$ that admits spreads, and let π and π' be two disjoint generators of \mathcal{P} . If \mathcal{L} is a Cameron-Liebler set of \mathcal{P} with parameter x , with characteristic vector χ , then the number of generators of \mathcal{L} disjoint to both π and π' equals $(x - (\chi)_\pi - (\chi)_{\pi'})q^{n(n-1)} \prod_{i=1}^{n-1} (q^{2i-1} - 1)$.

Proof. The proof is similar to the proof of Lemma 3.3. Denote the number of spreads of \mathcal{P} containing i given pairwise disjoint generators by n_i , $i = 2, 3$. By Lemma 6.8 we know this number is independent of the chosen generators.

We count the tuples (τ, S) with τ a generator of \mathcal{P} disjoint to both π and π' and S a spread of \mathcal{P} containing π , π' and τ . Using Lemmas 6.3 and 2.14 we find that

$$n_2(q^{2n-1} - 1) = n_3q^{n(n-1)} \prod_{i=1}^n (q^{2i-1} - 1) \Leftrightarrow \frac{n_2}{n_3} = q^{n(n-1)} \prod_{i=1}^{n-1} (q^{2i-1} - 1).$$

Now we count the tuples (τ, S) with τ a generator of \mathcal{P} disjoint to both π and π' that is contained in \mathcal{L} , and S a spread of \mathcal{P} containing π , π' and τ . On the one hand, there are n_2 spreads containing π and π' , and by Theorem 3.15(v) there are $x - (\chi)_\pi - (\chi)_{\pi'}$ elements of \mathcal{L} disjoint to both π and π' contained in this spread. On the other hand, for a given τ , there are n_3 spreads containing π , π' and τ . So, the number of generators of \mathcal{L} disjoint to both π and π' equals

$$\frac{n_2}{n_3} (x - (\chi)_\pi - (\chi)_{\pi'}) = (x - (\chi)_\pi - (\chi)_{\pi'}) q^{n(n+1)} \prod_{i=1}^{n-1} (q^{2i-1} - 1). \quad \square$$

Lemma 6.10. Let \mathcal{P} be one class of generators of a hyperbolic quadric $\mathcal{Q}^+(7, q)$ that admits spreads, and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . If

$$(x - 1)q^3 < c(q^3 + x(q^2 + q + 1)) - \binom{c+1}{2}(2q^2 + x(q+1)),$$

then there are no $c + 1$ pairwise disjoint generators in \mathcal{L} .

Proof. We follow the approach from [36, Lemma 5.2 and Lemma 6.5] and [28, Lemma 2.4].

Assume that π_0, \dots, π_c are $c + 1$ pairwise disjoint generators in \mathcal{L} . We denote the set of generators in \mathcal{L} that have a non-empty intersection with π_i by S_i and the set of generators that have non-empty intersections with both π_i and π_j by S_{ij} . It follows immediately from Theorem 3.15 and Lemma 6.9 that $|S_i| = q^3 + x(q^2 + q + 1)$ for all $i = 0, \dots, c$, and that $|S_{ij}| = 2q^2 + x(q + 1)$ for all $0 \leq i \neq j \leq c$.

Using the inclusion-exclusion principle we find that

$$|\mathcal{L}| \geq \left| \bigcup_{i=0}^c S_i \right| \geq \sum_{i=0}^c |S_i| - \sum_{0 \leq i < j \leq c} |S_{ij}|,$$

and hence,

$$\begin{aligned} x(q+1)(q^2+1) &\geq (c+1)(q^3+x(q^2+q+1)) - \binom{c+1}{2}(2q^2+x(q+1)) \\ \Leftrightarrow (x-1)q^3 &\geq c(q^3+x(q^2+q+1)) - \binom{c+1}{2}(2q^2+x(q+1)), \end{aligned}$$

a contradiction. □

Before presenting the classification theorem for Cameron-Liebler sets of a class of generators of $\mathcal{Q}^+(7, q)$, we recall the Erdős-Ko-Rado theorem for a class of generators of $\mathcal{Q}^+(7, q)$.

Theorem 6.11 ([34, Theorem 22] and [13, Remark 2.3.2]). A maximal Erdős-Ko-Rado set of generators of one class \mathcal{P} of a hyperbolic quadric $\mathcal{Q}^+(7, q)$ is a point-pencil (restricted to \mathcal{P}) or a base-solid (described in Example 4.7).

Theorem 6.12. Let \mathcal{P} be one class of generators of a hyperbolic quadric $\mathcal{Q}^+(7, q)$ that admits spreads, and let \mathcal{L} be a Cameron-Liebler set of \mathcal{P} with parameter x . If $x \leq \frac{\sqrt{3}-1}{2}q$, then \mathcal{L} is the union of x point-pencils whose vertices are pairwise non-collinear or \mathcal{L} is the union of x base-solids whose centers are pairwise disjoint.

Proof. We follow the approach from [36, Lemma 5.3, Theorem 5.4 and Corollary 5.5] and [28, Lemma 2.5, Lemma 3.1 and Theorem 3.2]. Let m be the largest integer such that there exist m pairwise disjoint generators π_1, \dots, π_m in \mathcal{L} . First we prove that $m \leq b = \left(1 - \frac{\sqrt{3}}{3}\right)q$, by showing that there cannot be $\lfloor b \rfloor + 1$ pairwise disjoint generators in \mathcal{L} . We want to use Lemma 6.10 and for this we have to prove that $f(\lfloor b \rfloor) \geq 0$ with

$$f(c) = c(q^3 + x(q^2 + q + 1)) - \binom{c+1}{2}(2q^2 + x(q+1)) - (x-1)q^3.$$

As f is a quadratic function with a negative leading coefficient, it is sufficient to check that $f(b) \geq 0$ and $f(b-1) \geq 0$. A straightforward calculation shows that

$$\begin{aligned} f(b) \geq 0 &\Leftrightarrow x \leq \frac{\sqrt{3}-1}{2}q + f_1(q) \quad \text{with} \quad f_1(q) = \frac{(2+\sqrt{3})q^2 + (2\sqrt{3}-3)q}{4q^2 - (\sqrt{3}-1)q - 3 + \sqrt{3}} \quad \text{and} \\ f(b-1) \geq 0 &\Leftrightarrow x \leq \frac{\sqrt{3}-1}{2}q + f_2(q) \quad \text{with} \quad f_2(q) = \frac{(5-2\sqrt{3})q^3 - (6-3\sqrt{3})q^2 - (3\sqrt{3}-3)q}{4q^3 + (\sqrt{3}+1)q^2 + (3\sqrt{3}-3)q + 6}. \end{aligned}$$

Since $f_i(q) \geq 0$ for $q \geq 2$ and $i = 1, 2$, we find the statement to be true: we have $m \leq b$.

We denote the set of generators that have a non-empty intersection with both π_i and π_j by S_{ij} , $1 \leq i \neq j \leq m$, and we denote the set of generators in \mathcal{L} that are disjoint to π_j , for all $j \neq i$, by L_i , $i = 1, \dots, m$. We know that $|S_{ij}| = 2q^2 + x(q+1)$, for all $1 \leq i \neq j \leq m$, by Theorem 3.15 and Lemma 6.9.

It is easy to see that $\pi_i \in L_i$ for any $i = 1, \dots, m$. Moreover any two generators in L_i must have a non-empty intersection since there are no $m+1$ pairwise disjoint generators in \mathcal{L} by assumption. Hence, the set L_i is an Erdős-Ko-Rado set of generators, and consequently, $L_i \subseteq \mathcal{L}_i$, with \mathcal{L}_i a maximal Erdős-Ko-Rado set of generators. It is straightforward that L_i contains all elements of \mathcal{L} meeting π_i that are not in $\cup_{j \neq i} S_{ij}$. Hence, $|L_i| \geq q^3 + x(q^2 + q + 1) - (m-1)(2q^2 + x(q+1))$ by Lemma 4.10.

Assume that there exists a generator $\pi \in \mathcal{L}_i \setminus L_i$ for some i . Again by Lemma 4.10, we know that π meets $x(q^2 + q + 1)$ generators of \mathcal{L} non-trivially. But, as π is contained in the maximal Erdős-Ko-Rado set \mathcal{L}_i , it meets all generators in L_i non-trivially. Consequently,

$$\begin{aligned} q^3 + x(q^2 + q + 1) - (m-1)(2q^2 + x(q+1)) &\leq x(q^2 + q + 1) \\ \Leftrightarrow q^3 &\leq (m-1)(2q^2 + x(q+1)) \end{aligned}$$

However,

$$\begin{aligned} (m-1)(2q^2 + x(q+1)) &\leq \left(\left(1 - \frac{\sqrt{3}}{3}\right)q - 1 \right) \left(2q^2 + \frac{\sqrt{3}-1}{2}q(q+1) \right) \\ &= q^3 - \left(\frac{5}{2} - \frac{\sqrt{3}}{3} \right) q^2 - \frac{\sqrt{3}-1}{2}q \\ &< q^3. \end{aligned}$$

We find a contradiction. Hence, $L_i = \mathcal{L}_i$ for all $i = 1, \dots, m$. So, \mathcal{L} is the union of the maximal Erdős-Ko-Rado sets \mathcal{L}_i , $i = 1, \dots, m$, which necessarily have to be pairwise disjoint.

By Theorem 6.11 each of these sets \mathcal{L}_i is either a point-pencil of \mathcal{P} or else a base-solid. Two point-pencils in \mathcal{P} are disjoint if and only if their vertices are non-collinear. Analogously, two base-solids in \mathcal{P} are disjoint if and only if their centers are disjoint. Finally, a point-pencil and a base-solid in \mathcal{P} cannot be disjoint. This finishes the proof of the theorem. \square

In the previous theorem we did not discuss the hyperbolic quadric $\mathcal{Q}^+(4n-1, q)$ for general n , but only the hyperbolic quadric $\mathcal{Q}^+(7, q)$. We know that the largest Erdős-Ko-Rado sets of $\mathcal{Q}^+(4n-1, q)$, $n \geq 3$, are point-pencils. So, to apply the approach that we used in the previous

proof, we need a result that gives an upper bound on the size of the maximal Erdős-Ko-Rado sets of $\mathcal{Q}^+(4n-1, q)$ different from a point-pencil. However, such a result is not available at the moment.

Summary

We summarize the classification results of this section in the following table.
